

लवि-इन रलेशनशिप के पंजीकरण हेतु वेब पोर्टल

चर्चा में क्यों?

राजस्थान [उच्च न्यायालय](#) ने राज्य सरकार को लवि-इन रलेशनशिप के पंजीकरण के लिये एक वेब पोर्टल शुरू करने का नरिदेश दिया है।

मुख्य बंदि

- **आदेश का कारण:** कई लवि-इन जोड़ों को परिवार और समाज से धमकियों का सामना करना पड़ता है, जिसके परिणामस्वरूप वे [अनुच्छेद 226](#) के तहत याचिका दायर कर [अनुच्छेद 21](#) के तहत सुरक्षा की मांग करते हैं।
 - अनुच्छेद 226 उच्च न्यायालयों को यह अधिकार प्रदान करता है कयिदकिसी नागरिक के अधिकारों और स्वतंत्रता का उल्लंघन होता है तो वे सरकारी संस्था के वरिद्ध मुकदमा दायर कर सकते हैं।
 - भारतीय संवधान के अनुच्छेद 226 के तहत उच्च न्यायालय को किसी भी व्यक्ति या प्राधिकारी को आदेश और रटि जारी करने की व्यापक शक्तियाँ प्राप्त हैं।

\[996\] \[997\] \[998\] \[999\] \[1000\]](#) जैसे कई मामलों में नरिणय दिया है कि ऐसे रशिते अपराधिक नहीं हैं और अनुच्छेद 21 द्वारा गारंटीकृत जीवन और व्यक्तिगत स्वतंत्रता के अधिकार के अंतर्गत आते हैं।
- **वनिियमिति करने की आवश्यकता:** न्यायालय ने लवि-इन संबंधों को वनिियमिति करने की आवश्यकता पर प्रकाश डाला तथा कहा कि इनमें सामाजिक स्वीकृति का अभाव है तथा ये कानूनी जटलिताएँ उत्पन्न कर सकते हैं, वशिषकर महिलाओं और बच्चों के लिये।
- **प्राधिकरण की स्थापना:** जब तक कानून नहीं बन जाता, न्यायालय ने प्रत्येक ज़िले में एक सक्षम प्राधिकरण के गठन का आदेश दिया है, जो लवि-इन जोड़ों की शिकायतों को पंजीकृत करेगा और उनका समाधान करेगा।
 - सरकार को 1 मार्च, 2025 तक एक अनुपालन रिपोर्ट प्रस्तुत करनी होगी, जिसमें उठाए गए कदमों की रूपरेखा होगी।
- **ववािहति व्यक्तियों पर कानूनी स्पष्टीकरण:** न्यायालय ने इस मुद्दे को बड़ी पीठ को भेज दिया कि क्या बिना तलाक लवि-इन रलेशनशिप में रहने वाले ववािहति व्यक्ति सुरक्षा की मांग कर सकते हैं।
- **लवि-इन जोड़ों के लिये नया कानूनी प्रारूप:**
 - न्यायालय के आदेश में एक औपचारिक पंजीकरण प्रारूप तैयार करना भी शामिल था जसि लवि-इन रलेशनशिप में प्रवेश करने वाले सभी जोड़ों को पूरा करना होगा। दस्तावेज़ के अनुसार जोड़ों को ऐसे रशिते में प्रवेश करने से पहले वशिषिट शर्तों पर सहमत होना होगा। प्रारूप में मुख्य प्रावधान नमिनलखिति होंगे:
 - **बाल सहायता:** दोनों भागीदारों को एक "बाल योजना" पर सहमत होने के लिये बाध्य किया जाएगा, जसिमें संबंध से पैदा होने वाले किसी भी बच्चे की शिक्षा, स्वास्थ्य देखभाल और सामान्य पालन-पोषण के लिये उनकी संबंधित ज़मिमेदारियों को रेखांकित किया जाएगा।
 - **भरण-पोषण:** पुरुष साथी को अनर्जक (गैर-कमाऊ) महिला साथी और संबंध से उत्पन्न बच्चों की आर्थिक सहायता करने तथा उनकी आर्थिक सुरक्षा सुनिश्चित करने की ज़मिमेदारी होगी।
