**Explanation:**

**Olive Ridley Turtles**

- The Olive ridley turtles are the smallest and most abundant of all sea turtles found in the world.
- Habitat: They are found in warm waters of the Pacific, Atlantic and Indian oceans. Hence, **Statement 2 is not correct.**
- **Protection Status:**
  - **IUCN Red List:** Vulnerable
  - **CITES: Appendix I. Hence, Statement 1 is correct.**
  - Indian Wildlife (Protection) Act, 1972: Schedule I

2. Consider the following statements:

1. Agappe Chitra Magna is a magnetic nanoparticle-based Deoxyribonucleic acid extraction kit.
2. It isolates mitochondria from the patient sample using magnetic nanoparticles.
3. It has been developed by the National Virology Institute.

**Answer: (d)**

**Explanation:**

- Agappe Chitra Magna is a magnetic nanoparticle-based RiboNucleic Acid (RNA) extraction kit. **Hence, Statement 1 is not correct.**
- It isolates RNA from the patient sample using magnetic nanoparticles. **Hence, Statement 2 is not correct.**
- The Sree Chitra Tirunal Institute for Medical Sciences and Technology (SCTIMST) in collaboration with Agappe Diagnostics Ltd.

has commercially launched the Agappe Chitra Magna Kit for detection of Covid-19. **Hence, Statement 3 is not correct.**

3. New START Treaty often seen in news is related to
- reduction and limitation of strategic offensive arms between the United States of America and Russia.
  - doctrine for establishment of peace between India and Pakistan.
  - building Confidence Building Measures between India- China due to recent border skirmishes.

**Explanation:**

- The new **Strategic Arms Reduction Treaty (START)** is a treaty between the United States of America and the Russian Federation on measures for the further reduction and limitation of strategic offensive arms. **Hence, Option (a) is correct.**

4. With reference to 'Open Skies Treaty', consider the following statements:

- India and the USA are not members of this treaty.
- It provides the signatory countries access to military bases for civil purposes.

Which of the statements given above is/are correct?

- 1 only
- 2 only
- Both 1 and 2

**Answer- (d)**

**Explanation:**

**Open Skies Treaty**

- It was signed in 1992 and came into effect in 2002.
- It is an agreement that allows its 34 signatory countries to monitor arm development by conducting surveillance flights (unarmed) over each other's territories. **Hence, Statement 2 is not correct.**
- Therefore, the treaty established an aerial surveillance system for its participants.
- India is not a member of this treaty. Both US and Russia are signatories of the treaty. **Hence, Statement 1 is not correct.**

5. With reference to 'Golden Crescent region', consider the following statements:

1. This region of the Middle East is a principal global site for opium production and distribution.
  2. It comprises Afghanistan, Iran, and Pakistan.

**Explanation:**

**Golden Crescent**

- This region of **South Asia** is a principal global site for opium production and distribution. **Hence, Statement 1 is not correct.**
  - It comprises **Afghanistan, Iran, and Pakistan**. **Hence, Statement 2 is correct.**
6. With reference to the National Innovation Foundation (NIF), consider the following statements:
1. It is an autonomous body under the Ministry of Skill Development and Entrepreneurship.

**Explanation**

- The National Innovation Foundation (NIF) - India was set up in **2000** as an autonomous body of the Department of Science and Technology (DST) under the Ministry of Science and Technology. **Hence, Statement 1 is not correct.**
- It is India's national initiative to strengthen the grassroots technological innovations and outstanding traditional knowledge. **Hence, statement 2 is correct.**

7. Consider the following statements regarding the coalitions of different nations to probe covid-19 origin:

1. The resolution to identify the zoonotic source of the coronavirus was proposed at the World Health Assembly.
2. It is supported by all the five permanent members of the UN Security Council.
3. From the South Asian Association for Regional Cooperation (SAARC) nations, only Bangladesh and Bhutan have signed up.

Which of the statements mentioned above is/are NOT correct?

**Answer: (c)**

**Explanation**

- Recently, 62 countries have proposed a resolution at the World Health Assembly to identify the zoonotic source of the coronavirus and demanded a comprehensive evaluation of the World Health Organisation response to the Covid crisis. **Hence Statement 1 is correct.**
  - The resolution is supported by only three of the five permanent members of the UN Security Council i.e. UK, Russia and France. **Hence statement 2 is not correct.**
  - From the South Asian Association for Regional Cooperation (SAARC) nations, only India, Bangladesh and Bhutan have signed up. **Hence statement 3 is not correct.**
8. With reference to 'Tropical Cyclones', consider the following statements:
1. Saffir-Simpson scale rates the severity of tropical cyclones.
  2. Tropical cyclones are called typhoons in the North Atlantic region.
  3. They rotate clockwise in the Northern hemisphere.

**Explanation**

- Saffir-Simpson scale provides 1-5 rating based on the tropical cyclones's intensity. **Hence, Statement 1 is correct.**
- Tropical cyclones are called typhoons in the North Pacific region. In the North Atlantic Region, they are called 'hurricanes'. **Hence, statement 2 is not correct.**

- They rotate counterclockwise in the northern hemisphere because of the coriolis effect. **Hence, Statement 3 is not correct.**

9. Consider the following statements:

1. A syndemic is a situation when two or more epidemics interact synergistically to produce an increased burden of disease in a population.
2. A disease called epidemic when a new disease for which people do not have immunity spreads around the world beyond expectations.
3. Epidemics are more severe than pandemic due to an unlimited area of spread.

**Explanation**

- A syndemic is a situation when two or more epidemics interact synergistically to produce an increased burden of disease in a population. **Hence, Statement 1 is correct.**
- An epidemic is a large outbreak, one that spreads among a population or region. A pandemic is declared when a new disease for which people do not have immunity spreads around the world beyond expectations. **Hence, Statement 2 is not correct.**
- Epidemics are less severe than pandemic due to a limited area of spread. **Hence, Statement 3 is not correct.**

Select the correct option using the code given below.

**Explanation**

- Johnson's line, McDonald line and Line of Actual Control (LAC) are associated with the India-China border.
- Line of Control (LoC) and Radcliffe line are associated with the India-Pakistan border. **Hence, Option C is correct.**

11. Which of the following locust species are found in India?

1. Desert Locust
2. Migratory Locust
3. Red Locust
4. Tree Locust

Choose the correct answer using the code given below:

- a. 1 and 2 only
- b. 1, 2 and 3 only
- c. 1, 2 and 4 only

**Answer: (c)**

**Explanation:**

- A locust is a large, **mainly tropical grasshopper** with strong powers of flight.
- **Four species of locust are found in India namely**
  - Desert Locust
  - Migratory Locust
  - Bombay Locust
  - Tree Locust

**Hence, Option (c) is correct.**

12. Regarding Pradhan Mantri Vaya Vandana Yojana, which of the following statements is **incorrect**?

- a. It was launched by the Ministry of Finance to offer a guaranteed payout of pension to senior citizens every month.
- b. Life Insurance Corporation (LIC) has been given the sole privilege to operate this Scheme.

**Explanation:**

Aadhar has been made **mandatory** to avail the benefit of the scheme. **Hence, Option (d) is not correct.** All other statements are correct.

1. The Star Rating Protocol is an initiative of the Quality Council of India to institutionalize a mechanism for cities to achieve Garbage Free status.

**Answer: (b)**

**Explanation:**

- The Star Rating Protocol was launched by the **Ministry of Housing & Urban Affairs (MOHUA) in 2018** to institutionalize a mechanism for cities **to achieve Garbage Free status**, and to motivate cities to achieve higher degrees of sustainable cleanliness. **Hence, Statement 1 is not correct.**
- The Star Rating is supported by **self-assessment and self-verification** for achieving a certain star rating. **Hence, Statement 2 is correct.**

14. Consider the following statements about Formalisation of Micro Food Processing Enterprises:

1. It is a Central Sector Scheme on All India basis with an outlay of Rs. 10,000 crore.
2. It aims to increase access to finance and revenue targets for the micro food processing enterprises.

**Explanation:**

- **Formalisation of Micro Food Processing Enterprises** is a **Centrally Sponsored Scheme (CSS)** on All India basis with an outlay of Rs.10,000 crore.
  - The expenditure will be shared by the Centre and the States in a ratio of **60:40**. **Hence, Statement 1 is not correct.**
- It intends to increase **access to finance and revenue targets for the micro food processing enterprises**. **Hence, Statement 2 is correct.**

  - Koraput Traditional Agriculture of Odisha.
  - Pampore Saffron Heritage of Kashmir.

**Hence, Option (d) is correct.**

15. Consider the following statements about Mount Harriet National Park:

1. It is located in the north Andaman Island.
2. Mount Harriet is the highest peak in the Andaman and Nicobar archipelago.
3. The park is covered with evergreen forest pockets.

- Mount Harriet is located in the south Andaman Is. **Hence statement 1 is incorrect.**

- The park is covered with evergreen forest pockets. **Hence statement 2 is incorrect.**

- It is rich in flora and faunal species like Andaman wild pigs, saltwater crocodiles, butterflies and palm trees. **Hence statement 3 is correct.**

- Recently, the Baltic countries of Estonia, Latvia and Lithuania started a travel bubble to help put their economies back on track after Covid-19 lockdowns. **Hence, Statement 4 is correct.**
