Jammu & Kashmir Budget 2026-27

Why in News?

On 6 February 2026, Jammu and Kashmir Government Chief Minister and Finance Minister **Omar Abdullah** presented the **Union Territory's annual budget** for the fiscal year 2026–27 in the Legislative Assembly.

Key Points:

- 💡 **Macro-Economic Aggregates & Fiscal Position:** The total budget outlay for 2026-27 is estimated at **₹1,27,767 crore**.
- 💡 **Gross Budget Estimates:** ~₹1,27,767 crore (including advances and overdrafts).
- 💡 **Net Budget Estimates:** ₹1,13,767 crore (excluding overdrafts/Ways & Means).
 - ✦ **Revenue Expenditure:** ~₹80,640 crore.
 - ✦ **Capital Expenditure:** ~₹33,127 crore.
- 💡 **Revenue Structure**
 - ✦ **Own Revenues:** ~₹31,800 crore estimated from tax and non-tax sources.
 - ✦ **Central Assistance:** ~₹42,752 crore, plus ₹13,400 crore under Centrally Sponsored Schemes (CSS).
 - ✦ **Projected GSDP Growth:** ~9.5%.
- 💡 **GSDP Growth:** Projected at 9.5%, with the nominal GSDP expected to reach **₹3,15,822 crore**.
- 💡 **Fiscal Deficit:** Targeted at **3.69% of GSDP**, aligning with the FRBM Act guidelines.
- 💡 **Sectoral Allocations (Top Priorities):** The budget follows a **"Bottom-Up"** approach, prioritizing rural infrastructure and human capital.
 - ✦ **Infrastructure & Roads:** Allocated **₹6,528 crore**. Key projects include the Z-Morh Tunnel and connecting "unconnected" habitations under PMGSY.
 - ✦ **Health & Medical Education:** Allocated **₹1,866 crore** (Capital). A major milestone is the scheduled commissioning of **AIIMS Awantipora (Kashmir)** by June 2026.

- ✦ **Agriculture & Allied Sectors:** Allocated **₹1,878 crore**. The focus remains on the Holistic Agriculture Development Programme (HADP), aiming to create 2.87 lakh jobs in the sector.
- ✦ **Education:** Earmarked **₹1,513 crore** (Capital) to implement the **National Education Policy (NEP) 2020** and upgrade 2,000 schools into "Smart Schools."
- 💡 **Major Welfare Initiatives & Social Security:** The Chief Minister announced **32 New Welfare Measures** aimed at the most vulnerable populations.
 - ✦ **AAY Support:** Six free LPG cylinders per year for **Antyodaya Anna Yojana** families.
 - ✦ **Education for All:** Full tuition fee waiver for AAY students in Classes 9–12 and Government Degree Colleges.
 - ✦ **Marriage Assistance:** The State Marriage Assistance Scheme (SMAS) grant increased to **₹75,000**.
 - ✦ **Orphan Support:** A monthly stipend of **₹4,000** for orphans under non-institutional care via DBT.
 - ✦ **Transit Accommodation:** Completion of **6,000 transit flats** for Kashmiri Migrant employees under the PM Development Package.
- 💡 **Power Sector Reforms:** J&K faces significant challenges in **Transmission & Distribution (T&D)** losses.
 - ✦ **Smart Metering:** The budget aims for **100% smart metering** in urban areas by December 2026 to curb AT&C losses.
 - ✦ **Generation:** Funding provided to expedite the **850 MW Ratle** and **624 MW Kiru** hydroelectric projects via the Chenab Valley Power Projects (CVPPPL).
- 💡 **Tourism as an Economic Pillar:** Tourism is recognized as a **key driver of economic growth and employment**.
 - ✦ Proposals for **Rs 180 crore** allocation for **Amarnath Yatra** infrastructure.

Tulbul Navigation Project in Jammu and Kashmir

Why in News?

The long-pending **Tulbul Navigation Project (TNP)** has re-emerged in focus on its **revival**, highlighting its **strategic, legal, and developmental significance** in the context of the **Indus Waters Treaty** and **water resource management in Jammu & Kashmir**.

Key Points:

- 💡 **Project:** The Tulbul Navigation Project is a proposed **lock-and-control structure** on the **Jhelum River** at the mouth of **Wular Lake in Jammu & Kashmir**, intended to regulate water flow.
- 💡 **Objective:** The primary aim is to maintain a **minimum water level** in the **Jhelum River** to ensure year-round **inland navigation between Srinagar and Baramulla**.
- 💡 **Background:** The project was conceived in the early **1980s**, and construction began in **1984** but was halted in 1987 following objections from Pakistan.
 - ✦ **Pakistan** objected to the project under the provisions of the **Indus Waters Treaty**, arguing that it violated treaty clauses related to **storage and control** of western rivers.
- 💡 **India's Stand:** India maintains that the project involves **non-consumptive** use of water and is permissible under the **treaty framework**.
- 💡 **Significance:** The project could improve inland water transport, assist in **flood control**, support **hydropower generation** during lean seasons, and enhance **water management** in the **Kashmir Valley**.
 - ✦ Discussions on revival have gained traction amid changing dynamics surrounding the **Indus Waters Treaty** and renewed focus on **water resource utilisation** in Jammu & Kashmir.

J&K shelved the Dal Lake restoration plan

Why in News?

The **Jammu and Kashmir government** decided to shelve the ₹416.72-crore restoration and conservation plan for the famous Dal Lake in Srinagar, primarily due to its **poor implementation outcomes** and a strategic shift toward **in-situ conservation**.

Key Points:

- 💡 **Reasons for Shelving the 2009 Plan:** Over 17 years, the project achieved only **27% of its conservation goals**.
 - ✦ **Failed Relocation:** The plan originally aimed to relocate approximately **9,000 families** to the Rakh-e-Arth colony but only **1,808 families** were rehabilitated.
 - ✦ **Unsuitable Resettlement Site:** The Rakh-e-Arth site was **low-lying and flood-prone**, requiring massive expenditures on land filling rather than actual infrastructure.
- 💡 **The 2009 Plan:** The shelved restoration and preservation plan, introduced in 2009.
- 💡 **New "In-Situ" Policy Shift:** The government is pivoting to a model that recognizes lake dwellers as an **integral part of the ecosystem** rather than encroachers to be removed.
 - ✦ **Eco-Hamlets:** 58 internal hamlets will now be developed as **"eco-hamlets,"**.
 - ✦ **New Investment:** A new **₹212.38-crore** Detailed Project Report (DPR) drafted by **IIT Roorkee** has been proposed under the Prime Minister's Development Package.
- 💡 **Focus Areas:** This new five-year plan focuses on installing modular **Sewage Treatment Plants (STPs)**, dredging interior channels, and reviving internal water circulation.

Adoption of New High-Density Apple Rootstocks in Kashmir

Why in News?

Scientists and horticulture experts have introduced **new high-density apple rootstocks** in **Kashmir Valley**, promising **early fruiting, higher productivity, and better farm incomes**, especially for small and marginal orchardists.

Key Points:

- 💡 **Apple Economy of Kashmir:** Jammu & Kashmir is one of India's leading apple-producing regions.
 - ✦ Apple cultivation contributes **~8–9% to J&K's GSDP** and supports **over 3.5 lakh families**
- 💡 **Traditional Method:** Traditional orchards in the region, which often rely on older seedling rootstocks, typically take up to **10 years** to produce their first fruits.
 - ✦ In contrast, new systems using dwarf rootstocks like **M9** can yield fruit as early as the **second year**.
- 💡 **Rootstock:** The root part of a grafted plant onto which a desired apple variety (scion) is grafted.
 - ✦ It determines tree size, yield efficiency, disease resistance and adaptability to soil and climate
- 💡 **New Apple Rootstocks:** It includes **Dwarf and Semi-Dwarf Rootstocks** which include **M9, M26 and MM series**.
- 💡 **Benefits:** Enable **high-density plantation (HDP)**
 - ✦ **Yield Increase:** High-density orchards can produce **50–70 metric tonnes per hectare**, compared to only 10–12 tonnes in conventional systems.
 - ✦ **Quality & Price:** Fruit grown on these rootstocks often has better color, firmness, and size.
 - ✍ These apples can fetch market prices of **₹100–140 per kg**, nearly double the rate of traditional varieties.

- ✦ **Labor Efficiency:** Smaller trees simplify labor-intensive tasks like pruning and thinning.

- 💡 **Government Support:** The Jammu and Kashmir Horticulture Department is actively supporting this shift through the **High Density Apple Plantation Scheme**, which offers a **50% subsidy** to farmers switching to these modern systems.

Regional Science Centres Project in Jammu and Kashmir

Why in News?

The **Jammu and Kashmir government** announced the establishment of a **Regional Science Centre** in Jammu and a **Sub-Regional Science Centre** in Srinagar to foster scientific temperament and innovation.

Key Points:

- 💡 **Sub-Regional Science Centre, Srinagar:** Will function as a feeder institution linked to the Regional Science Centre.
 - ✦ **Total Cost & Funding:** Approved at ₹18.20 crore, with the Government of India fully funding the ₹14.00 crore capital cost and sharing the ₹4.20 crore corpus fund.
 - ✦ **Progress:** The R&B Department, Kashmir, utilized ₹1.24 crore in 2024–25, with 2025–26 plans focusing on land development and construction.
 - ✦ **Features:** The center will include a planetarium, an innovation hub, and a Science Innovation Dissemination Centre, which is being built at an additional cost of ₹2.79 crore.
- 💡 **Regional Science Centre, Jammu:** Will serve as a hub-level science centre for the Jammu region and expected to cater to:
 - ✦ School and college students
 - ✦ Teachers and researchers
 - ✦ General public

Two New Wetlands Added to India's Ramsar List

Why in News?

Union Environment Minister **Bhupender Yadav** announced the addition of **two new wetlands** to India's **Ramsar List**, ahead of **World Wetlands Day 2026**.

Key Points

- 💡 **New Ramsar Sites:** **Patna Bird Sanctuary** in **Etah district of Uttar Pradesh** and **Chhari-Dhand** in **Kutch district of Gujarat** have been included in **India's Ramsar list** of wetlands of international importance.
 - ✦ India's Ramsar network has grown from **26 sites in 2014 to 98 sites in 2026**.
- 💡 **Patna Bird Sanctuary:** Patna Bird Sanctuary is one of the **smallest protected bird sanctuaries** and is an **Important Bird and Biodiversity Area (IBA)**.
- 💡 **Chhari-Dhand Wetland:** A **seasonal saline wetland** in the **Rann of Kutch region**, crucial for **migratory waterfowl and desert biodiversity**.
 - ✦ It is Gujarat's **fifth Ramsar site** after Nalsarovar, Thol, Khijadiya and Wadhvana.
- 💡 **Importance:** The newly added sites support **hundreds of migratory and resident bird species** and host wildlife such as **chinkara, wolves, caracal, desert cats and desert foxes**, besides endangered bird species.
- 💡 **Significance:** Inclusion in the Ramsar list reflects **international recognition of India's commitment** to wetland conservation and sustainable management under globally accepted frameworks.
- 💡 **Ramsar Convention:** It is an international treaty for the conservation and sustainable use of wetlands, signed in 1971 at Ramsar, Iran.
 - ✦ India became a signatory on 1 February 1982.
- 💡 **World Wetlands Day 2026:** It is observed on 2 February.
 - ✦ **Theme: Wetlands and Traditional Knowledge: Celebrating Cultural Heritage**

PAIMANA Portal Launched by MoSPI

Why in News?

The **Ministry of Statistics & Programme Implementation (MoSPI)** has operationalised **PAIMANA** — a new **web-based monitoring portal** for Central Sector Infrastructure Projects worth **₹150 crore and above**.

Key Points

- 💡 **PAIMANA:** It stands for **Project Assessment, Infrastructure Monitoring & Analytics for Nation-building** and is a **centralized digital platform** to monitor large infrastructure projects.
 - ✦ It has replaced the earlier **OCMS-2006 (Online Computerised Monitoring System)** to improve real-time tracking and analytics.
- 💡 **Integration:** PAIMANA is integrated with the **DPIIT's Integrated Project Monitoring Portal** using **APIs (Application Programming Interface)**, enabling **automatic data flow** and reducing manual data entry.
 - ✦ The integration follows the principle of **"one data, one entry"** to standardise project reporting and minimise errors.
- 💡 **Project Coverage:** As of **December 2025**, a total of **1,392 ongoing central sector infrastructure projects** have been onboarded on the PAIMANA portal.
- 💡 **Sectoral Spread:** Projects span key sectors including **Transport & Logistics, Railways, Coal, Power, Housing & Urban Affairs, Water Resources, Telecommunications, Health & Family Welfare**, etc.
- 💡 **Features:** The portal offers **interactive dashboards, advanced analytics, role-based access, automated reports and query modules** for better oversight and decision-making.
- 💡 **Objective:** To enhance **transparency, data quality and timely implementation** of major infrastructure projects, supporting **nation-building and economic growth**.

Meghalaya's Living Root Bridges Nominated for UNESCO World Heritage List

Why in News?

India has submitted the nomination dossier of **Meghalaya's Living Root Bridges**—titled “**Jingkieng Jri / Lyu Chrai Cultural Landscape**”—to **UNESCO**.

Key Points

- 💡 **Nomination Submitted:** India's Ambassador to UNESCO, **Vishal V. Sharma**, handed over the **nomination dossier** to the Director of **UNESCO's World Heritage Centre**.
- ✦ **Heritage Value:** The nomination highlights the **cultural, ecological and technological significance** of the living root bridges, emphasizing **traditional ecological stewardship** and generational knowledge.
- 💡 **Location:** The bridges are mainly located across the **southern slopes of the Khasi and Jaintia Hills** in Meghalaya.
- 💡 **Cultural Significance:** These bridges are **bio-engineered structures** created and maintained by **indigenous Khasi and Jaintia communities**.
 - ✦ Symbolizing a **deep harmony between people, nature, and traditional knowledge**.
- 💡 **Global Recognition:** If approved, the site will receive **UNESCO World Heritage status**, bringing global recognition and boosting **conservation efforts and sustainable tourism**.

US Museum to Return Three Ancient Bronze Sculptures Stolen from Tamil Nadu to India

Why in News?

The **Smithsonian's National Museum of Asian Art** announced it would return three ancient bronze sculptures to India. The decision follows a multi-year provenance investigation which confirmed the artefacts were illegally removed from **temples in Tamil Nadu**.

Key Points:

- 💡 **Repatriated Sculptures:** The three relics are masterpieces of South Indian bronze casting, originally used as sacred procession icons in temple rituals:
 - ✦ **Shiva Nataraja:** A Chola-period masterpiece dating to circa **990 CE**.
 - ✦ **Somaskanda:** A **12th-century** Chola bronze depicting Shiva with his wife Parvati and son Skanda.
 - ✦ **Saint Sundarar with Paravai:** A **16th-century** Vijayanagar-period bronze depicting the Tamil saint and his wife.
- 💡 **Identification:** The sculptures' original locations were confirmed using rare 1950s photographs from the **French Institute of Pondicherry** archives.
- 💡 **Original Sites:** The **Shiva Nataraja** was stolen from the **Sri Bhava Aushadesvara Temple** in Thanjavur district.
 - ✦ The **Somaskanda** was traced to the **Visvanatha Swamy Temple** in Alathur village, Thiruvavur district.
 - ✦ The **Saint Sundarar** sculpture originated from a Shiva temple in **Veerasolapuram village**, Kallakurichi district.
- 💡 **Museum's Ethical Commitment:** The Smithsonian museum cited its **ethical stewardship and transparency policies**, including its **Shared Stewardship and Ethical Returns Policy**, as the basis for agreeing to repatriate the sculptures.
- 💡 **Cultural heritage restoration:** Return of sacred temple bronzes strengthens India's efforts to reclaim its **artistic lineage and religious history**.

- 💡 **Disciplines:** It is awarded in fields not covered by the Nobel Prizes: **Mathematics, Astronomy, Geosciences, and Biosciences.**

- ✦ **Technical Risks:** Space-based hardware is highly vulnerable to **solar flares, radiation, and micrometeorite impacts**.

WHO Prequalifies India-Made Novel Oral Polio Vaccine (nOPV2)

Why in News?

- 💡 **Massive Production Capacity:** Biological E. is expected to produce **600 million doses annually**, significantly diversifying the global supply beyond the original manufacturer in Indonesia.
- 💡 **Flexible Logistics:** The vaccine has a **24-month shelflife** and can be stored at standard temperatures for up to six months, making it easier to deploy in remote areas.
- 💡 **World Polio Day:** It is observed every year on **24th October** in order to call on countries to stay vigilant in their fight against the disease

Corruption Perceptions Index 2025

Why in News?

The **Corruption Perceptions Index (CPI) 2025**, released by **Transparency International**, ranks **182 countries and territories** on a scale from **0 (highly corrupt)** to **100 (very clean)** based on expert assessments and business perception surveys drawn from 13 independent data sources.

- 💡 **Strategic Importance:** The official recognition of **Freestyle Chess by FIDE** signals increasing acceptance of **innovative formats** in **international chess competitions**.

Russia Blocks WhatsApp, Promotes State-Backed App

Why in News?

The **Russian government** has **blocked access to the Meta-owned messaging app WhatsApp** and imposed restrictions on **Telegram**, Russia's two most widely used foreign messaging platforms.

Key Points:

- 💡 **WhatsApp Ban:** Russia has fully **blocked WhatsApp**, citing the platform's alleged refusal to comply with **Russian laws and regulatory requirements**.
 - ✦ The ban was implemented because WhatsApp did not meet **local legal and security obligations**.
- 💡 **Regulator:** The restrictions are enforced by **Roskomnadzor, Russia's state communications regulator**.
- 💡 **Shift to State App:** The Russian government is actively promoting **Max**, a **state-supported messaging and super-app**, as a replacement for foreign-owned services.

- ✦ Authorities have introduced **restrictions on the platform's functionality** and accused it of failing to remove **extremist or prohibited content**.

- 💡 **National Security Narrative:** Russian authorities argue that restricting foreign messaging apps is necessary for **national security**.
 - ✦ These platforms allegedly facilitate **criminal activity, fraud, and foreign intelligence access**.
- 💡 **Public Reactions:** Digital rights groups **criticised** the WhatsApp ban and Telegram restrictions, saying they **undermine privacy and free communication** while promoting **state-controlled platforms** as part of **Russia's push for digital sovereignty**.

First Indigenous Cadet Training Ship 'Krishna' Launched in Chennai

Why in News?

The **Indian Navy** launched its first indigenously designed and built **Cadet Training Ship (CTS) 'Krishna'** at the **L&T Shipyard in Kattupalli, Chennai** in **February 2026**.

Key Points:

- 💡 **First Indigenous CTS:** 'Krishna' is the **first of three Cadet Training Ships** being constructed by **Larsen & Toubro (L&T)** for the Indian Navy under a contract signed with the **Ministry of Defence**.

- 💡 **Strategic Significance:** The initiative is expected to deepen **India-EU cooperation on migration and mobility**, strengthen ties in **education and employment**, and create mutually beneficial opportunities for both regions' **talent and economies**.
- 💡 **Economic & Skills:** The office reflects recognition of **India's large and skilled workforce**—particularly in **digital, scientific, and emerging technologies**—and its contribution to global talent pools, while supporting EU employers and institutions to engage with **Indian talent**.

Kerala Declares Tidal Flooding a 'State-Specific Disaster'

Why in News?

In a pioneering move for climate-sensitive policy, the Kerala government recently declared **tidal flooding** (sea incursion during high tides) as a **State-Specific Disaster**.

- 💡 **Tidal Flooding Definition:** Also known as '**Sunny Day Flooding**' or 'Nuisance Flooding,' it occurs when sea levels rise above the local threshold during high tides, even in the absence of storms or heavy rainfall.
- 💡 **The Kerala Context:** In districts like **Ernakulam (Kochi), Alappuzha, and Thrissur**, seawater enters homes and shops twice a day through the backwaters and drainage systems, leading to chronic waterlogging.
- 💡 **Why the "Disaster" Tag?:** Historically, disaster relief was reserved for "sudden-onset" events like cyclones or landslides. Kerala's shift is based on several critical factors:
 - ✦ **Frequency and Intensity:** Due to **Climate Change and Sea Level Rise (SLR)**, high tides are reaching further inland.
 - 📌 What was once a minor inconvenience is now a daily threat to life and property.

- ✦ It will adopt a **hub-and-spoke approach** connecting academia, research institutions, industry partners, and government agencies to promote R&D interventions, innovation ecosystems, and skill development at the grassroots level.

 - ✦ In the **2026–27 fiscal year**, NHAI plans to plant **about 40 lakh trees** along National Highways, with close to **60 % of these allocated under the Bee Corridor initiative**.
 - ✦ At least **three dedicated pollinator corridors** are expected to be developed during this period.

Union Cabinet Approves Renaming Kerala to 'Keralam'

Why in News?

The **Union Cabinet** has approved the proposal to rename the state of **Kerala** as “**Keralam**”, aligning the state’s official name with its usage in the Malayalam language.

- 💡 **Background:** The term “**Keralam**” is the native Malayalam name of the state and has been in continuous cultural and linguistic use for centuries.
- 💡 **Ancient References:** The term finds mention as “**Keralaputra**” in Emperor Ashoka’s **Rock Edict II (257 BCE)**, referring to the **Chera dynasty**.
- 💡 **Linguistic Reorganisation:** The demand for a united ‘**Keralam**’ for Malayalam-speaking communities dates back to the national freedom struggle.
 - ✦ **Colonial Name:** The English name “**Kerala**” emerged during colonial administration and was retained after Independence.
- 💡 **Resolution:** The **Kerala Legislative Assembly** had earlier unanimously passed a resolution seeking the name change and forwarded it to the Centre for approval.
- 💡 **Constitutional and Legal Basis:** **Article 3 of the Indian Constitution** empowers Parliament to form new states and alter the **name, area, or boundaries** of existing states.

- 💡 **Procedure:** The procedure requires:
 - ✦ A bill introduced in Parliament on the recommendation of the President.
 - ✦ Prior reference of the bill to the concerned State Legislature for its views (which are not binding).
 - ✦ Following Cabinet approval, the proposal will be introduced as a bill in Parliament to formally effect the change.
- 💡 **Parliamentary Approval:** Once the Bill is introduced, it must be passed by a simple majority of members present and voting in both the Lok Sabha and the Rajya Sabha.
- 💡 **Presidential Assent:** Following the passage, the Bill is sent for Presidential assent.
- 💡 **Amendment of Schedules:** Once the Act is notified, the **First Schedule** (which lists the names of the states) and the **Fourth Schedule** (which deals with the allocation of seats in the Rajya Sabha) of the Constitution are updated accordingly.

Zimbabwe launches long-acting HIV-prevention injection Lenacapavir

Why in News?

Zimbabwe has become one of the **first African countries** to launch **Lenacapavir**, a **long-acting injectable drug for HIV prevention**, marking a major milestone in the continent’s fight against HIV/AIDS.

Key Points:

- 💡 **About Lenacapavir:** Lenacapavir is a **long-acting antiretroviral medicine** used for **HIV pre-exposure prophylaxis (PrEP)**.
- 💡 **Mechanism of Action:** Developed by Gilead Sciences, Lenacapavir is a **capsid inhibitor**. It works by interfering with the HIV-1 viral capsid (the protein shell protecting the virus’s genetic material) at multiple stages of its lifecycle, rendering the virus dysfunctional.
- 💡 **Biannual Protection:** Lenacapavir is the world’s first **twice-yearly** (six-month) injectable for pre-exposure prophylaxis (PrEP).

- 🔦 **WHO Prequalification:** The WHO prequalified the drug in October 2025 and released implementation guidelines in July 2025.

- 🔦 **Target Population:** The initial phase targets approximately **46,500 high-risk individuals** across 24 sites nationwide, including adolescent girls, young women, sex workers, and pregnant or breastfeeding mothers.
- 🔦 **Funding and Support:** The program is supported by the United States government and the **Global Fund**, offering the drug free of charge to vulnerable groups.
- 🔦 **Efficacy:** Clinical trials demonstrated **near 100% effectiveness** in preventing HIV infections, significantly outperforming daily oral PrEP pills.

UN Launched Road Safety Financing Project in Four Indian States

Why in News?

The **United Nations Road Safety Fund (UNRSF)** has launched a **Sustainable Road Safety Financing Project** in India, aiming to strengthen financial mechanisms and capacity for road safety interventions in selected states.

- 🔦 The project was inaugurated in **New Delhi** during the visit of the **UN Secretary General’s Special Envoy for Road Safety, Jean Todt**.

Key Points:

- 🔦 **Objective:** The initiative aims to establish sustainable and coordinated **financing mechanisms** for road safety programmes at national and state levels.

- 🔦 **Sustainable Financing Strategies:** The project promotes innovative financing tools such as **road safety bonds, dedicated taxes, and public-private partnerships (PPP)** to ensure predictable funding streams for road safety.
- 🔦 **Capacity Building:** A core component is strengthening **institutional capacity** at national and sub-national levels for **planning, budgeting, and monitoring** road safety investments.
- 🔦 **Global Alignment:** The initiative supports the **Global Plan for the Decade of Action for Road Safety 2021–2030**, which seeks to halve road fatalities and serious injuries worldwide by 2030.

Rob Jetten Becomes Netherlands’ Youngest and First Openly Gay Prime Minister

Why in News?

Rob Jetten has been sworn in as the **Prime Minister of the Netherlands**, making history as both the **youngest person** and the **first openly gay leader** of the country. He assumed office in **February 2026**.

- 💡 **Expansion of Initiative:** The Eat Right Station programme complements other national efforts to improve public health, such as **Swachh Bharat Mission and Safe Water initiatives**, and encourages other **railway zones** to adopt similar standards.
