PM MITRA Textile Park in Karnataka

Why in News?

The Karnataka government has assured execution of the **PM MITRA Textile Park** in Kalaburagi.

Key Points

- 💡 **Project Location:** The PM MITRA Textile Park is planned in Kalaburagi district, part of the Kalyana Karnataka region.
- 💡 **PM MITRA Scheme:** PM MITRA (Pradhan Mantri Mega Integrated Textile Region and Apparel) Parks are **large integrated textile clusters** covering the entire textile value chain from fibre to finished products.
- 💡 **National Significance:** Kalaburagi is one of the **seven locations selected across India** under the PM MITRA scheme.
- 💡 **Other Seven Location under the PM MITRA scheme are:**
 - ✦ Tamil Nadu – Virudhunagar
 - ✦ Telangana – Warangal
 - ✦ Gujarat – Navsari
 - ✦ Karnataka – Kalaburagi
 - ✦ Maharashtra – Amravati
 - ✦ Madhya Pradesh – Dhar
 - ✦ Uttar Pradesh – Lucknow–Hardoi region
- 💡 **Employment Generation:** The project is expected to **create large-scale direct and indirect employment**, particularly benefiting local youth and skilled workers.
- 💡 **Industrial Growth:** The textile park aims to **attract private investment, promote exports**, and enhance India's global competitiveness in textiles.

KSRTC grants paid menstrual leave from Jan 2026

Why in News?

The **Karnataka State Road Transport Corporation (KSRTC)** has issued a circular granting **one day of paid menstrual leave every month** to women employees.

Key Points

- 💡 **Policy Implementation:** KSRTC has adopted the **paid menstrual leave provision** from January 2026.
- 💡 **Eligibility:** The leave benefit is available to **women employees aged 18–52 years**.
- 💡 **Leave Conditions:** Women can take the monthly menstrual leave **without any medical certificate**.
- 💡 **Utilization:** The leave must be used in the **same month** and cannot be carried forward.
- 💡 **Annual Entitlement:** Women are entitled up to **12 days of paid menstrual leave annually**.
- 💡 **Policy Rationale:** The circular follows the **Karnataka Menstrual Leave Policy-2025**, which mandates menstrual leave across workplaces in the state, making Karnataka one of the **first states in India** to adopt such a policy.

Sirsi to Host Karnataka's Second Monkey Fever Testing Laboratory

Why in News?

Karnataka is establishing its **second Kyasanur Forest Disease (KFD) testing laboratory** in Sirsi to enhance disease detection and control efforts in the state.

Key Points

- 💡 **Location:** The testing laboratory will be set up in **Sirsi**, in **Uttara Kannada district** of Karnataka.
- 💡 **Purpose:** It is being established to **handle increased testing demand**, improve **diagnostic capacity**, and enable **earlier detection** of KFD cases.
- 💡 **Disease Background:** **Kyasanur Forest Disease**, also called **Monkey Fever**, is a **tick-borne viral disease** endemic to parts of Karnataka and other regions.
 - ✦ **Symptoms :** Fever, headache, body pain, chills, fatigue, vomiting etc.
 - ✦ **Treatment:** **No specific antiviral treatment** available but needs supportive care, antipyretics, pain relief, hydration and preventive measures.

President Takes Submarine Sortie in Karnataka

Why in News?

President **Droupadi Murmu** undertook a historic **submarine sortie** onboard the Indian Navy's indigenous submarine **INS Vaghsheer** at the **Karwar Naval Base** in Karnataka.

Key Points

- 💡 **Second President:** She became the **second Indian President** to undertake such a submarine sortie (first was Dr A.P.J. Abdul Kalam in 2006).
- 💡 **Indigenous Submarine:** **INS Vaghsheer** is part of the **Project-75 Scorpene** programme and is one of the Indian Navy's indigenously **built diesel-electric submarines**.
- 💡 **Accompanied by Naval Chief:** The President was accompanied by **Chief of Naval Staff Admiral Dinesh K. Tripathi**.
- 💡 **Maritime Security Focus:** The sortie reflects India's emphasis on **maritime defence preparedness** and the importance of submarines in securing the **Indian Ocean Region**.

Buddhist Conference in Karnataka

Why in News?

Union Minister **Kiren Rijiju** addressed a **Buddhist Conference** at **Mundgod Tibetan Settlement**, Karnataka.

- 💡 **India-Tibet Relations:** Reiterated **historical civilisational and cultural ties** between India and Tibet.

- 💡 **Location:** A town in **Uttara Kannada district**, Karnataka, India.
- 💡 **Mini-Tibet:** The town is known as "Mini Tibet of India" due to the large Tibetan refugee settlement.
- 💡 **Cultural Significance:** Centre of Tibetan Buddhist culture, traditions and monastic education in India.
 - ✦ Acts as a hub for Buddhist conferences, teachings and spiritual interactions, often attended by the Dalai Lama.
- 💡 **Attiveri Bird Sanctuary:** Located near Mundgod is home town for a number of species of birds including migratory birds.
 - ✦ The Sanctuary houses birds like Little Cormorant, Spoonbill, Indian shag, Cattle Egret, pied Kingfisher, White-breasted Kingfisher, White Ibis, Common Grey Hornbill and Common Swallow.

India to Host 2nd WHO Global Summit on Traditional Medicine

Why in News?

India will host the **Second WHO Global Summit on Traditional Medicine in New Delhi** from 17–19 December 2025, building on the inaugural summit held in Gandhinagar, Gujarat, in 2023.

Key Points

- 🔦 **Organiser:** Jointly organised by the **World Health Organization (WHO)** and the **Ministry of Ayush** to advance global dialogue on health and well-being through traditional medicine.
- 🔦 **Theme:** The summit will be held under the theme **"Restoring balance: The science and practice of health and well-being,"** focusing on equitable, sustainable health systems.
- 🔦 **Global Focus:** Policymakers and leaders from over 100 countries will participate **to shape the future role of traditional medicine.**
- 🔦 **Vision:** The event aims to reaffirm the relevance of traditional medicine while promoting its integration into **national health systems** based on science, evidence and responsible practice.
- 🔦 **WHO Strategy:** Discussions will align with the **WHO Global Traditional Medicine Strategy 2025–2034** to advance people-centred healthcare and planetary well-being.
- 🔦 **Plenary Sessions:** Key deliberations will cover **restoring balance in health systems, scientific investment, governance, biodiversity stewardship, and Indigenous rights.**
- 🔦 **Innovation & Evidence:** The summit will emphasize innovative approaches to elevate traditional medicine responsibly **through ethical use of digital technologies,** including AI.
- 🔦 **Diverse Issues:** Over 25 sessions will address regulation, integration, protection of biodiversity, and intellectual property rights.

WHO

- 🔦 **Founded:** 7 April 1948, headquartered in Geneva, Switzerland.
- 🔦 **Type:** Specialized agency of the **United Nations** for global public health.
- 🔦 **Membership:** **194 member states** (as of 2025).
- 🔦 **Objective:** Promote **health**, achieve **Universal Health Coverage (UHC)**, and respond to **global health emergencies.**
- 🔦 **Current Director-General:** Dr **Tedros Adhanom Ghebreyesus** (since 2017).

Nuclear Energy Transformation Bill, 2025

Why in News?

Dr **Jitendra Singh**, Minister of State for **Science and Technology**, introduced the **Sustainable Harnessing and Advancement of Nuclear Energy for Transforming India Bill, 2025**, in Parliament to modernise India's nuclear energy legal framework.

Key Points

- 🔦 **New Legal Framework:** The Bill proposes a comprehensive law for nuclear energy by repealing the **Atomic Energy Act, 1962** and the **Civil Liability for Nuclear Damage Act, 2010.**
- 🔦 **Energy Security:** It aims to expand nuclear installed capacity to ensure **reliable, clean and round-the-clock power** for future needs such as **data centres.**
- 🔦 **Decarbonisation Goal:** The Bill aligns with India's long-term climate commitments, including a target of **100 GW nuclear power capacity by 2047** and **net-zero emissions by 2070.**
- 🔦 **Private Participation:** It encourages greater involvement of the **domestic industry and the private sector** in nuclear power development.
- 🔦 **Regulatory Mechanism:** The Bill introduces updated provisions for **licensing, safety authorisation, suspension and cancellation** to strengthen regulatory oversight.

- 💡 **Fuel:** Uranium & Thorium (India has largest Thorium reserves).

- 💡 **Defence Estates Role:** The Department manages the largest landholding of the Government of India under the **Ministry of Defence**.
- 💡 **Digital Transformation:** Modernised land management with projects like **E-Chhawani**, providing 100% municipal services online to ~20 lakh cantonment residents.

- 💡 **Objective:** To strengthen India's geospatial ecosystem and advance the **National Geospatial Mission**.
- 💡 **Participants:** Will bring together policymakers, technologists, industry leaders and domain experts.
- 💡 **Announced:** The **National Geospatial Mission** (announced in the Union Budget 2025–26) aims to modernise geodetic frameworks, enhance geospatial infrastructure, standardise data, and adopt emerging technologies.
- 💡 **Significance:** A key step in realising the Viksit Bharat 2047 vision through enhanced geospatial capabilities.

25,000 Jan Aushadhi Kendras by March 2027

Why in News?

The Government has set a new target to increase the number of **Pradhan Mantri Bhartiya Janaushadhi Kendras (JAKs)** in India to **25,000 by March 2027**.

Key Points

- 💡 **Current Status:** As of **30 November 2025**, a total of **17,610 Janaushadhi Kendras (JAKs)** have been opened nationwide, compared to only **80 in 2014**, showing significant expansion of the scheme.
- 💡 **Target Set:** The Government has set a target of increasing JAKs to **25,000 by March 2027** to further improve access to low-cost quality generic medicines.
- 💡 **About Jan Aushadhi Kendra:** It is a **government-supported retail outlet** scheme that sells **quality generic medicines at affordable prices** to the public.
- 💡 **Growing Awareness:** Rising **sales volumes** and an expanding **product basket** under the scheme indicate increasing public confidence and awareness about Janaushadhi medicines.
- 💡 **Entrepreneur Participation:** Enhanced viability and attractiveness of JAKs have led to a **37% increase in outlets** and a **38% increase in MRP sales value** in the last financial year.

Sahakar Sarathi

Why in News?

The **Government of India** has established **Sahakar Sarathi**, a **Shared Service Entity (SSE)**, to modernise and digitally empower **Rural Cooperative Banks (RCBs)**.

Key Points

- 💡 **Establishment of Sahakar Sarathi:** Sahakar Sarathi (SSE) has been set up with the approval of the **Reserve Bank of India (RBI)** to strengthen the technological and service capabilities of **Rural Cooperative Banks**.
- 💡 **Date of Registration:** The entity was **registered on 21 July 2025** with the aim of providing shared infrastructure for cooperative banking digitalisation.
- 💡 **Authorised Capital & Shareholding:** Sahakar Sarathi has an **authorised capital of ₹1,000 crore**, with equal **33.33% shareholding** each for **NABARD, NCDC**, and **Rural Cooperative Banks**.
- 💡 **Services Provided:** It offers **shared modern banking infrastructure** and digital services including: **Common Core Banking Solutions (CBS), Digital payments** like AePS and UPI, **Cybersecurity, IT governance** etc.
- 💡 **Purpose & Impact:** The initiative seeks to help RCBs provide **modern, standardised, and digital banking services**, enhance customer reach, and improve **operational efficiency** comparable to other regulated financial institutions.

NAMASTE Scheme: Nationwide Survey of Sewer and Septic Tank Workers

Why in News?

A **nationwide survey** covering over **4,800 Urban Local Bodies (ULBs)** was conducted under the **National Action**

for Mechanised Sanitation Ecosystem (NAMASTE) scheme to identify **Sewer and Septic Tank Workers (SSWs)** and strengthen their **safety and dignity** in sanitation work.

Key Points

- 💡 **Survey Objective:** The survey was conducted to identify **Sewer and Septic Tank Workers (SSWs)** under the NAMASTE scheme — **not manual scavengers** — to ensure improved working conditions and safety.
- 💡 **Fatality Data:** According to the **National Commission for Safai Karamcharis (NCSK)**, **471 sanitation workers** have lost their lives due to hazardous sewer and septic tank cleaning between **2019 and October 2025**.
- 💡 **Legal Prohibition:** **Section 7** of the **Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013** prohibits hazardous entry into sewer or septic tanks.
- 💡 **NAMASTE Scheme:** Launched in **2023–24** by the **Department of Social Justice & Empowerment** in convergence with the **Ministry of Housing & Urban Affairs**
- 💡 **Scheme Objectives:** The scheme aims to **eliminate manual entry** into sewer and septic tanks and promote **mechanised cleaning** to achieve **zero fatality** and protect workers health.
- 💡 **Scheme Components:** Support includes **safety devices** for Emergency Response Sanitation Units (ERSUs), **capital subsidies** for mechanised equipment, **occupational safety training**, and **workshops** on prevention of hazardous cleaning.
- 💡 **SBM-U 2.0 Linkage:** Under **Swachh Bharat Mission – Urban (SBM-U) 2.0**, the **Used Water Management (UWM)** component focuses on eradicating hazardous sewer/septic tank entry through mechanisation.

The **Government of India** informed about **White Spot Disease outbreaks** in aquaculture in **Andhra Pradesh**

and the measures taken under the **Pradhan Mantri Matsya Sampada Yojana (PMMSY)** to monitor and control aquatic animal diseases.

Key Points

- 💡 **White Spot Disease:** In Andhra Pradesh, field teams collected aquaculture samples; **4 samples tested positive under passive surveillance** and **23 under active surveillance** for **White Spot Syndrome Virus (WSSV)**.
- 💡 **Disease Surveillance:** The **National Surveillance Programme for Aquatic Animal Diseases (NSPAAD)** is being implemented under **PMMSY** with a **₹33.78 crore outlay** to detect and manage aquatic diseases nationwide.
- 💡 **Sample Analysis:** Samples are analysed at the **State Institute of Fisheries Technology (SIFT), Kakinada**.
- 💡 **Insurance Support:** Under the **Aquaculture Crop Insurance Scheme**, **85 aquafarmers** in Andhra Pradesh are covered; in 2025, **₹5.21 lakh** in claims were disbursed.
- 💡 **Prevention Guidelines:** The **Coastal Aquaculture Authority** has issued guidelines for **SPF shrimp or broodstock centres, hatcheries, farms, health monitoring and SPF certification** to prevent WSSV outbreaks.
- 💡 **Biosecurity Measures:** Mandatory **quarantine of imported shrimp broodstock** and registration of shrimp hatcheries and farms with the **Coastal Aquaculture Authority** are enforced to limit disease spread.
- 💡 **Laboratory Surveillance:** **PCR-based disease surveillance** of shrimp and water samples supports early detection and disease control.
- 💡 **Alternative Farming:** The Government promotes **Biofloc Technology (BFT)** and **Recirculatory Aquaculture Systems (RAS)** to reduce disease risk and improve biosecurity and sustainability.

- 💡 **Consumer Confidence:** Products complying with **IS 19412:2025** are eligible to carry the **BIS Standard Mark**, enabling consumers to identify **safe, tested, and quality-assured** incense sticks.
- 💡 **Prohibited Substances:** The standard restricts the use of **insecticidal chemicals** such as **alethrin, permethrin, cypermethrin, deltamethrin, and fipronil**.
- 💡 **Product Coverage:** It applies to **machine-made, hand-made, and traditional masala agarbattis**, prescribing norms for **raw materials, burning quality, fragrance performance, and permissible chemical limits**.

- 📌 **Ballistic missiles:** They are **rocket-propelled weapons** that follow a **free-fall trajectory** after launch. They can carry **conventional or nuclear warheads** and be launched from **land, sea, or air**.
 - ✦ Based on range, they're classified as **short** (< 1,000 km), **medium** (1,000–3,000 km), **intermediate** (3,000–5,500 km), or **long-range or intercontinental ballistic missiles (ICBMs)** (> 5,500 km).
 - ✦ **Agni-V** is India's longest-range missile, an ICBM with a range of over 5,000 km.

Bharat Taxi Initiative

Why in News?

The Government of India has launched **Bharat Taxi**, a **first-of-its-kind driver-owned, cooperative ride-hailing initiative**, aimed at providing a fair, transparent and equitable alternative to private taxi aggregators.

Key Points

- 📌 **Bharat Taxi:** It is a **government-backed ride-hailing platform** developed as a **cooperative model**, where **drivers are shareholders and co-owners** instead of being dependent on traditional private companies.
