Rajasthan Victim Compensation Scheme, 2011

Why in News?

In compliance with the directions issued under the Action Plan 2025–26 of the **Rajasthan State Legal Services Authority**, a meeting of the **Victim Compensation Scheme** was held in July 2025. The committee approved a total compensation amount of ₹14.25 lakh under the Victim Compensation Scheme.

Key Points

- 💡 **Rajasthan Victim Compensation Scheme, 2011:** It aims to provide financial assistance to victims of crime or their dependents for medical expenses, rehabilitation, and funeral costs.
- ✦ Administered by the **District Legal Services Authority (DLSA) or State Legal Services Authority (SLSA)**, the scheme supports victims who have not received compensation under any other scheme.

State Legal Services Authority:

- 💡 The State Legal Services Authority (SLSA) is constituted under the **Legal Services Authorities Act, 1987**, to implement the mandate of **Article 39-A of the Constitution**, which ensures equal justice and free legal aid.
- ✦ Each state government sets up an SLSA to provide free and competent legal services to the weaker sections of society and to organize Lok Adalats for speedy dispute resolution.
- 💡 The SLSA is headed by the **Chief Justice of the High Court as Patron-in-Chief**, with a sitting or retired High Court Judge as Executive Chairman (nominated by the Governor in consultation with the Chief Justice).
- 💡 It ensures that justice is accessible, inclusive, and affordable, regardless of economic or social barriers.

Lumpy Skin Disease

Why in News?

Fresh cases of **Lumpy Skin Disease (LSD)** in cows have recently been reported in the **Sirohi district, Rajasthan**, three years after the region was devastated by the same disease.

Key Points About Lumpy Skin Disease

- 💡 **Causes:** LSD is caused by **infection of cattle or water buffalo** with the **poxvirus Lumpy Skin Disease Virus (LSDV)**.
 - ✦ According to the **Food and Agriculture Organization (FAO)**, the mortality rate is less than 10%.
 - ✦ Lumpy skin disease was first seen as an **epidemic in Zambia in 1929**. Initially, it was thought to be the result of either poisoning or hypersensitivity to insect bites.
- 💡 **Transmission:** Lumpy skin disease is primarily **spread between animals** by biting insects (vectors), such as mosquitoes and biting flies.
- 💡 **Symptoms:** The disease is **marked by the appearance of lumps on the skin of infected cows** and can lead to a reduction in milk production and, in severe cases, death.
 - ✦ It primarily consists of **fever, fluid excretion from eyes and nose**, dribbling of saliva from the mouth and blisters on the body.
- 💡 **Prevention and Treatment:** Vaccination against these diseases is covered under the **Livestock Health and Disease Control Programme of India**.
 - ✦ There are **no specific antiviral drugs available** for the treatment of lumpy skin disease.
 - 📎 The only treatment available is supportive care of cattle. This can include treatment of skin lesions using wound care sprays and the use of antibiotics to prevent secondary skin infections and pneumonia.
 - ✦ **Anti-inflammatory painkillers** can be used to keep up the appetite of affected animals.





LUMPY SKIN DISEASE IN CATTLE

- Called LSD for short, it is caused by a poxvirus
- It is transmitted through the bite of an infected mosquito or tick

- It can spread through saliva & nasal secretions

LSD is not a zoonotic disease, which means it can't infect people



MAIN SYMPTOM

Skin nodules/lumps in one area or all over the body



THE EFFECT IN CATTLE

- Reduced milk production
- Reduced male fertility
- Weight loss
- Pregnancy loss

TREATMENT

- No specific remedy
- Antibiotics, anti-inflammatory drugs & vitamins are prescribed to prevent a secondary infection

In Malaysia, just 0.1% of 81,252 head of cattle tested at 9,108 farms have the disease

Bhilwara's Ashwini Vishnoi Wins Gold at U-17 WWC

Why in News?

Bhilwara's Ashwini Vishnoi made history by winning a gold medal at the Under-17 World Wrestling Championship (WWC), which took place in Athens, Greece (from 28th July to 3rd August 2025).

- In a spectacular display of skill and determination, she triumphed over Uzbekistan's Mukayo Rakhimjonova 3-0 in the final.
- This victory marks her as Rajasthan's first female wrestler to win this prestigious title, boosting her prominence internationally.

Key Points

- In her first match, she defeated a wrestler Mukayo Rakhimjonova from Uzbekistan.
 - She then won her second match against a wrestler from Kazakhstan.
 - Ashwini advanced to the final, where she faced China's Jiaao in the 65 kg category and won the match easily, securing the gold medal.
- In the last two years, Ashwini has not only gained national recognition but has earned five international gold medals, solidifying her place on the global stage.

- ✦ She has won multiple **gold medals**, including triumphs at the **Asian Wrestling Championship** and the **World Wrestling Championship**.

World Wrestling Championship (WWC)

- 💡 The WWC is **organized by United World Wrestling (UWW)**. United World Wrestling (UWW) is the international governing body for the sport of amateur wrestling, both for **Greco-Roman wrestling (men only)** and **freestyle wrestling (men's and women's)**.
- 💡 UWW is **headquartered** in Corsier-sur-Vevey, Switzerland.

Rajasthan Investment Promotion Scheme (RIPS)

Why in News?

The Rajasthan government has disbursed **₹765.78 crore in investment incentives** under the Rajasthan Investment Promotion Scheme (RIPS) for the 2024-25 fiscal year.

Key Points

- 💡 **About:** RIPS 2024 is the Rajasthan government's flagship scheme to **promote investments** across manufacturing, services, **renewable energy**, **MSMEs**, startups, and sunrise sectors.
 - ✦ Launched at a **UK roadshow in October 2023**, the scheme operates until 31st March 2029, with potential revisions as needed.
- 💡 **Priority Sectors and Categories:**
 - ✦ Manufacturing, services, sunrise sectors, MSMEs, startups, industrial infrastructure, logistics, warehousing, R&D, and global capability centers.
 - ✦ Special focus on women, youth, and startups; logistic infrastructure requires minimum investments ranging from ₹2 crore (warehouse or cold chain) to ₹50 crore (**multi-modal logistics parks**).
- 💡 **Key Incentives:**
 - ✦ **Capital Subsidy:** Up to 28% of eligible investment for some sectors.
 - ✦ **SGST Reimbursement:** Up to 75% of State **GST** for a defined period.

- ✦ **Stamp Duty Reimbursement:** Up to 75% exemption and reimbursement for the remainder.
- ✦ **Renewable Energy Focus:** 100% exemption of electricity duty, 75% exemption in stamp duty and conversion charges (remainder reimbursed), banking and transmission exemptions, and dedicated benefits for **green hydrogen** and energy storage.

Eligibility:

- ✦ For new/expansion investments and for projects starting commercial production within the operative policy period or two years from entitlement, whichever is later.
- ✦ Eligible entities may access single-window clearance through the **Rajnivesh portal**, streamlining applications and approvals.

Implementation and Scale:

- ✦ Rajasthan has signed MoUs worth ₹35 lakh crore as per the 2024 **Rising Rajasthan Global Investment Summit**, with over ₹4.12 lakh crore under implementation.
- ✦ Regular partnership conclaves and roadshows to attract both domestic and global investors.
 - 📎 The Rajasthan government will host the Rising Rajasthan Partnership Conclave in Jaipur on 11-12 December 2025 to further strengthen partnerships with industry leaders, institutions, and multilateral bodies, **continuing the momentum of investment** and collaboration in the state.

Key Facts About Rajasthan

- 💡 Rajasthan is the **largest State** in the country in terms of area.
 - ✦ It is spread over the geographical area of about 3.42 lakh square kilometres, which is **10.41% of India's total land area**.
- 💡 It is located in the **northwest part of the country** and is surrounded by the States of Punjab, Haryana, Uttar Pradesh, Madhya Pradesh, and Gujarat.
- 💡 The Gross State Domestic Product (GSDP) for 2023-24 is USD 182.02 billion, with a **GSDP growth rate of 8.03%** at constant prices (2011-12).

A historical controversy has erupted following a claim in the NCERT (National Council of Educational Research and Training) textbook where Jaisalmer is depicted as part of the **Maratha Empire**.

Historians' Arguments on Maratha Relations with Jaisalmer

- 💡 **Rajput's Arguments:** The royal family of Jaisalmer, led by Chaitanya Raj Singh, the 44th Maharawal of Jaisalmer, has strongly objected to this portrayal, calling it a grave historical error and highlighting that there is **no evidence of Maratha influence in Jaisalmer**—a region that remained independent throughout various invasions, including those by the Mughals and the British.
- 💡 Historical accounts reveal that the region's Rajput rulers defended their sovereignty, and there was **no Maratha intervention or taxation in Jaisalmer**.
- 💡 **Maratha's Arguments:** Maratha historians cite the **1752 Ahadnama** (a pact between Mughal Emperor Ahmad Shah Bahadur and Maratha commanders Malharrao Holkar and Mahadji Shinde) and argue that, while the **Marathas did not have direct day-to-day control**, **Rajput states**, including Jaisalmer, were **made to pay chauth and sardeshmukhi taxes**.
 - ✦ Pandurang Balkawade (historian from Pune) points to Peshwa administration records showing regular collection of **chauth from the Ajmer (Mewar) region**.

Jaisalmer

- 💡 **Location & Significance:** Jaisalmer, often referred to as the “Golden City,” is located in **western Rajasthan**, close to the **Pakistan border and the Thar Desert**.
 - ✦ Its prominent landmark is the **Jaisalmer Fort**, also known as **Sonar Qila** (Golden Fort), which is unique for being a living fort.

- 🔦 **Historical Background:** Jaisalmer was founded in 1156 by Rawal Jaisal, a descendant of the Yaduvanshi clan. After being passed over for the throne of Lodurva, Jaisal sought a new capital, guided by the prophecy of sage Eesul (local hermit).
- 🔦 **Cultural Heritage:** Jaisalmer's cultural and architectural beauty is shaped by its Rajput heritage, with influences from the Bhati Rajputs.
- 🔦 **Geological Significance:** The Wood Fossil Park (Akal) in Jaisalmer shows fossils from the Thar Desert for a glimpse into geological history, dating back 180 million years.
- 🔦 **Post-Independence:** Jaisalmer State signed the Instrument of Accession with India on 7th April 1949, merging with the Indian Union.

Marathas

- 🔦 **Origin & Language:** The Marathas (speak Marathi language) are native to the Deccan Plateau, mainly present-day Maharashtra.
- 🔦 **Shivaji Maharaj & the Rise of Maratha Power:**
 - ✦ **Born (1630):** Shivaji, from the Bhonsle clan, aimed to establish **Swarājya** (sovereignty).
 - ✦ **Military Campaigns:** At 16, he began capturing forts in the Pune region, growing his influence.
 - 📌 Utilized guerrilla tactics against the Bijapur Sultanate, including defeating General Afzal Khan.
 - ✦ After Shivaji's death, Sambhaji (Shivaji's son) became the Chhatrapati. He was captured and executed by Aurangzeb.
- 🔦 **Maratha Structural Transformation:**
 - ✦ **Decentralization:** After Shivaji's death, the Maratha power became more decentralized, with the Peshwa gaining influence.
 - ✦ **Expansion:** The Marathas expanded across India, briefly controlling parts of Lahore, Attock, and Peshawar.

Rajasthan's Government Hospital to offer CAR-T Cell Therapy

Why in News?

SMS Hospital in Jaipur will become the first government hospital in Rajasthan to establish a dedicated Department of Clinical Haematology (DCH), offering CAR-T Cell Therapy.

Key Points

- 🔦 **About:** SMS Hospital has established a **Department of Clinical Haematology (DCH)** for the treatment of all types of haematological **cancers** and blood disorders, including bleeding disorders and **bone marrow transplants**.
 - ✦ This new department will offer CAR-T Cell Therapy, an advanced treatment option that has been previously available only at private hospitals in the state.
 - ✦ While the department is currently based at SMS Hospital, it will eventually be moved to the **State Cancer Institute** for better infrastructure and facilities.
- 🔦 **CAR-T Cell Therapy:**
 - ✦ **About:** CAR-T Cell Therapy, or **Chimeric Antigen Receptor T-Cell Therapy**, is India's first indigenous gene therapy for cancer treatment.
 - 📌 This innovative therapy is based on **genetic modifications** and offers a promising treatment for certain cancers, including **blood cancers**.
 - 📌 It modifies a patient's T-cells (a type of immune cell) to fight cancer more effectively.
 - 👤 A patient's T-cells are extracted from their blood and genetically modified (to recognize and attack cancer cells).

🧑 These modified cells, known as Chimeric Antigen Receptor (CAR) T-cells, are **multiplied and reintroduced** into the patient to target B-cells and prevent relapses.


✍ The therapy was developed in India at just a **tenth of the cost** compared to its international price, making it more accessible to Indian patients.

✦ **Importance:** India's CAR T-cell therapy provides an **additional, patient-specific treatment option**, as the modified T-cells remain in the body, offering long-term immunity against cancer recurrence.

✍ It is a patient-specific treatment, making it **highly precise** compared to traditional chemotherapy.

✍ Notably, an **82-year-old woman from Jaipur** became the oldest recipient of CAR-T therapy in the country.

✦ **NexCAR19:** In 2023, **NexCAR19** became India's first **approved indigenous CAR-T cell therapy**, developed through a collaboration between IIT Bombay, Tata Memorial Centre, and ImmunoACT (a company incubated at IIT Bombay).

Rajasthan's First Sex-Sorted Semen Lab for Cattle

Why in News?

Rajasthan's first sex-sorted semen lab for cattle was inaugurated by Dairy Minister Joraram Kumawat on 11th August 2025 at Bassi, Jaipur, and aims to enhance livestock quality, breed improvement, and milk production in the state.

Key Points

- 💡 **Operation:** The lab will operate under the **Rajasthan Cooperative Dairy Federation (RCDF)** with support from the National Dairy Development Board (NDDB), based in Anand, Gujarat.
 - ✦ A tripartite Memorandum of Understanding (MoU) was signed by RCDF, **Rajasthan Livestock Development Board (RLDB)**, and NDDB Dairy Services (NDS) for the management and operation of the Bassi Semen Station.
 - ✦ The MoU aims to enhance the production and supply of both **conventional and sex-sorted semen** doses for artificial insemination in Rajasthan.
- 💡 **Purpose & Impact:** The lab aims to **enhance cattle genetics** for improved milk production in the region by providing livestock farmers with affordable, high-quality semen doses for artificial insemination.
- 💡 **Production and Pricing:** The annual production capacity is **10 lakh doses of semen**, with varying pricing based on sex-sorted, indigenous conventional, and imported breed semen, and extra doses may be sold to other agencies at market rates.

- 💡 **Significance:** The Bassi Semen Station is set to become a key resource in Rajasthan, not only for semen production but also as an **educational and support center for livestock farmers**, driving forward both the **economic and environmental goals** of the dairy industry in the region.

BSF Launches 'Operation Alert'

Why in News?

The Border Security Force (BSF) has launched a week-long security operation called '**Operation Alert**' along the Indo-Pak border in Rajasthan.

Key Points

- 💡 **About:** The operation will run between 11th August 2025 to 17th August 2025 and is aimed at strengthening security and preventing any infiltration attempts ahead of India's Independence Day.
- 💡 **Objectives:**
 - ✦ **Strengthen surveillance** to prevent **infiltration and smuggling**, especially in the sensitive areas adjoining Sriganganagar and Bikaner.
 - ✦ Respond to intelligence reports suggesting potential disturbances orchestrated by Inter-Services Intelligence (ISI) leaders in Pakistan.
 - ✦ Focus on preventing narcotic smuggling via drones, particularly in areas prone to such activities.
- 💡 **Personnel Involved:** BSF soldiers and officers from all branches are participating in the operation, with additional soldiers deployed to sensitive areas.
 - ✦ The BSF will also **conduct outreach programs** with border residents to increase awareness and cooperation.

CENTRAL ARMED POLICE FORCES (CAPF)

The CAPF includes the seven security forces in India functioning under the Ministry of Home Affairs.

Assam Rifles (AR)

- ↳ **Origin:** 1835, as militia called 'Cachar Levy'
 - ⇒ **Erstwhile objective:** To protect British Tea estates
- ↳ **Current Objectives:**
 - ⇒ Conducting anti-terrorist operations in NER
 - ⇒ Ensuring security at India-China and India-Myanmar borders
- ↳ **Imp Role in:**
 - ⇒ Sino-India War 1962
 - ⇒ Indian Peace Keeping Force (IPKF) to Sri Lanka (1987)

Due to long association with tribal belts, Assam Rifles are also called 'Friends of the North East'

Border Security Force (BSF)

- ↳ **Origin:** 1965
- ↳ **Objectives:**
 - ⇒ Securing land borders with Pakistan and Bangladesh
 - ⇒ Also performing Anti-Infiltration in Kashmir Valley
 - ⇒ Counter Insurgency in NER
 - ⇒ Anti-Naxal Operations in Odisha and Chhattisgarh
- ↳ **Wings:** Air wing, marine wing, an artillery regiment, and commando units

BSF is India's First Line of Defence and the world's largest border guarding force

Central Reserve Police Force (CRPF)

- ↳ **Pre-Independence Origin:** 1939 (Crown Representative's Police)
- ↳ **Post Independence:** 1949 - under CRPF Act, became Central Reserve Police Force
- ↳ **Objective:** Crowd control, riot control, counter militancy/insurgency operations, etc.

CRPF is the principle central police force for internal security

Indo-Tibetan Border Police (ITBP)

- ↳ **Origin:** 1962
- ↳ **Objectives:**
 - ⇒ Deployed on border from Karakoram Pass (Ladakh) to Jachep La (Arunachal Pradesh) (~3488 km of Indo-China Border)
 - ⇒ Manning Border Outposts on altitudes 9000 ft - 18700 ft in Western, Middle and Eastern sectors of Indo-China Border

ITBP is India's specialised mountain force & the first responder to natural disasters

National Security Guard (NSG)

- ↳ **Origin:** 1984 (came into being in 1986), following Operation Blue Star
- ↳ **Objectives:** Counter-terrorism unit/Federal Contingency Force
- ↳ **Task-oriented Force - Two complementary elements:**
 - ⇒ Special Action Group (SAG)
 - ⇒ Special Ranger Groups (SRG)

Sashastra Seema Bal (SSB)

- ↳ **Origin:** 1963
- ↳ **Objectives:**
 - ⇒ Guarding Indo-Nepal and Indo-Bhutan borders
 - ⇒ Enhance border security, curb trans-border crimes, prevent unauthorised entry/exit, halt smuggling, etc.

Central Industrial Security Force (CISF)

- ↳ **Origin:** Central Industrial Security Force Act, 1968
- ↳ **Objectives:** Ensuring security of major critical infrastructure installations

CISF is the sole CAPF unit with a specialised fire wing

Aravali Green Development Project

Why in News?

The Rajasthan government has launched the **Aravali Green Development Project** aimed at **ecological restoration** and **desertification control** across 3,700 hectares in 19 districts along the Aravali range.

Key Points

- 💡 **About:** The Rs 250 crore project, spanning **five years**, aims to restore the **Aravali ecosystem**, combat land degradation and desertification, with the first year focused on plantation and the following year on maintenance.
 - ✦ The project is aligned with the **Aravali Green Wall Project**, which aims for massive plantations across the Aravalis, **from Delhi to Ahmedabad**.
- 💡 **Geographical Focus:** The project spans **19 districts** from **Alwar to Sirohi**, covering approximately 550 kilometers (80% of the Aravali range in Rajasthan).
- 💡 **Monitoring and Oversight:** The project will be monitored by the **Union Ministry of Environment, Forest, and Climate Change** using indicators like flora and fauna recovery, **groundwater level changes**, and microclimatic shifts.
- 💡 **Project Goals:**
 - ✦ Restoration of the deteriorating Aravali ecosystem.
 - ✦ Prevention of sandstorms from the **Thar Desert** reaching the National Capital Region (NCR) serving as an **ecological defense mechanism** for North India.
 - ✦ Combat **soil erosion**, **desertification**, and the adverse impacts of deforestation.
 - ✦ Helps in improving biodiversity, groundwater recharge, and **long-term ecological sustainability**.
- 💡 **Plantation Strategy:**
 - ✦ Indigenous and climate-resilient species, including **Khejri (state tree)**, **Babool**, **Dhak**,

Neem, **Ber**, and native grasses like **Sevan** and **Dhaman** for soil stabilization.

- ✦ Species chosen for their adaptability to varying climates (dry zones in Sikar to humid areas in Dungarpur and Sirohi).
- ✦ **Plantation will occur exclusively on forest land**, avoiding areas with human habitation or encroachments.
- ✦ Long-term sustainability is emphasized with careful maintenance to ensure the survival of saplings in **arid zones like Jaipur and Sikar**.

Country's First Drone-Based Cloud Seeding Experiment

Why in News?

The state agriculture department of **Rajasthan** launched the **first-ever drone-based cloud seeding experiment** to address the **water crisis** in the region and revive the **Ramgarh Lake**.

Key Points

- 💡 **Technology Used:** The cloud seeding process is powered by an **AI-driven platform** called **Hydro Trace**, which uses real-time data, **satellite imaging**, and sensor networks to target the right clouds at the right time accurately.
- 💡 **Approvals:** The technology received approvals from multiple bodies, including the **Directorate General of Civil Aviation (DGCA)**, the India Meteorological Department, district authorities, and the agriculture department.



Cloud seeding

Traditional method of rainmaking, in use since the 1940s



Cloud Seeding

- It is a **weather modification technique** that enhances precipitation by dispersing chemicals like **silver iodide**, **potassium iodide**, or **dry ice** into clouds, serving as nuclei for water droplet formation, leading to rainfall.
- It can help **combat air pollution**, especially during periods of high **Air Quality Index (AQI)** readings.
- Cloud seeding may **increase water availability** and result in economic, environmental, and human health benefits.

Cloud Seeding Techniques

Dynamic Cloud Seeding


Enhances vertical air currents to promote rain cloud growth.

Glaciogenic Cloud Seeding

Induces ice formation in clouds to trigger precipitation.

Hygroscopic Cloud Seeding

Uses salt particles to increase cloud droplet size.

Lesser Florican Conservation Crisis

Why in News?


The unchecked release of stray dogs from Nasirabad and Ajmer into the forested expanse of **Arwar Conservation Reserve** has emerged as a grave threat to the **Lesser Florican**.

Key Points

- 💡 **Decline in Population:** The **Lesser Florican (*Sypheotides indicus*)**, once common in Rajasthan's monsoon **grasslands**, has experienced a catastrophic 97% decline.
- ✦ In the year 2025, **only one male was spotted in the breeding grounds** of Ajmer, Kekri, and Shahpura, a sharp decrease from 39 in 2020.
- ✦ A landscape survey by the **Bombay Natural History Society (BNHS)** highlighted the species' dwindling numbers, with the lone male observed near Bandanwara.

WHY THEY ARE AT RISK

- Lesser floricans are critically endangered according to the IUCN
- They are shy and cannot tolerate human presence
- Loss of habitat due to declining grasslands



- Pesticide usage in breeding grounds
- Threat of destruction of eggs due to human activity

Lesser Florican (*Sypheotides Indicus*)

- 💡 It is one of **three bustard species** endemic to India, the others being the **Bengal florican** (Critically Endangered) and the **Great Indian Bustard** (Critically Endangered).
- 💡 It is the **smallest of the bustard family** and is renowned for its spectacular **leaping breeding display**.
- 💡 In the local language, the bird is known as '**tanmor**' or '**kharmor**', derived from the root word 'mor' for peacock.
- 💡 It is mainly observed in Rajasthan, Madhya Pradesh, and Gujarat.

Conservation status:

- ✦ **IUCN Status:** Critically Endangered
- ✦ **Wildlife Protection Act, 1972:** Schedule I
- ✦ **CITES:** Appendix II

AIDS

- 💡 **State's Long-Term Vision:** Rajasthan currently has **2,369 Sanskrit schools**. The project will roll out in **three phases**:
 - ✦ **Phase 1:** Sanskrit will be introduced in **757 new pre-primary Sanskrit schools**, set to open within a month.
 - ✦ **Phase 2 & 3:** Sanskrit will be introduced in **962 Mahatma Gandhi English Medium Schools (MGEMS)** and **660 PM-Shree Schools** across Rajasthan by next year.
- 💡 **Alignment with NEP:** The books align with the **National Education Policy (NEP)** and include concepts such as **numbers, days of the week, body parts, and moral stories**.

Sanskrit Language

- 💡 It is an **Indo-Aryan language** and is considered to be **one of the oldest languages**, and is known as the **mother of most languages of India**.
- 💡 It is believed to have **originated in India around 3500 years ago** and is often referred to as **Dev Vani (the language of the deities)**.
- 💡 It is divided into **two parts** which are **Vedic** and **classical**.
 - ✦ **Vedic Sanskrit** is the **older and more archaic form of Sanskrit**, which is attested in the **Rig Veda, the Upanishads, and the Puranas**.

- ✦ **Classical Sanskrit** is the later and **more standardised form of Sanskrit**, which is **based on the grammar of Panini** and used in literature, philosophy, science, and art.

Note

- 💡 Sanskrit is **among the 22 official languages** included in the **Eight Schedule of the Indian Constitution**.
- 💡 It is also included **among 11 Classical languages** besides Tamil, Telugu, Kannada, Malayalam, Odia, Marathi, Pali, Prakrit, Assamese, and Bengali.
- 💡 In **2010, Sanskrit was declared the second official language of Uttarakhand**.
- 💡 In **Mattur village of Karnataka, everyone speaks in the Sanskrit language**.

Rajasthan to Set Up 'Language Lab'

Chief Minister Bhajanlal Sharma has announced the establishment of a **'Language Lab'** to offer foreign language training to the youth.

PM Micro Food Processing Enterprises Scheme (PMFME)

Why in News?

Under the **Prime Minister's Micro Food Processing Enterprises Scheme (PMFME)**, entrepreneurs in **Jaipur** and **Rajasthan** are eligible for a **35% subsidy** for setting up or expanding food processing industries.

- The **Ministry of Food Processing Industries (MoFPI)** is implementing a centrally sponsored **PM Formalisation of Micro Food Processing Enterprises Scheme (PMFME)** Scheme for providing financial, technical, and business support to micro food processing enterprises in India.

Key Points

- Subsidy Details:** The **PMFME Scheme** provides a subsidy of **35%** of the eligible project cost or **₹10 lakh**, whichever is lower, for setting up new food processing units.
 - This financial assistance is aimed at industries related to **fruits and vegetables, grains, dairy products, oilseeds, animal feed, bakery products**, and other food products like **sago** and **asafoetida**.
- Application Process:** Applicants must apply **online** through the **PMFME-MOFPI Portal**.
 - The **State Nodal Agency** for the scheme is the **Rajasthan State Agricultural Marketing Board** based in **Jaipur**, with the **Agricultural Produce Market Committee (APMC)** serving as the **district-level nodal agency**.
- Support for Applicants:** The government has appointed **District Resource Persons (DRPs)** to assist applicants with application procedures, including **loan details** and **scheme-related guidance**.
- Eligibility and Requirements:** The project cost does **not include land costs**, and **technical civil work** should not exceed **30%** of the total project cost.
 - The scheme is valid until **31st March 2026**, and aims to establish **634 food processing units** in **Jaipur district** alone.

Status of the Food Processing Industry in India

- About:** Food processing is a **type of manufacturing** in which **raw materials** are **processed** into intermediate foods or edible items using scientific knowledge and technology.
 - It improves the storability, portability, palatability, and convenience of the finished product.
- Significance:**
 - As per the latest Annual Survey of Industries (ASI) 2019-20, **12.2%** of persons in the registered manufacturing sector were employed in the food processing sector.
 - The value of agri-food exports, including processed food exports, was about **10.9 %** of India's total exports during 2021-22
- Government Initiatives:**
 - 100% Foreign Direct Investment (FDI)** approval under automatic route has been permitted for the food processing sector
 - A Special Food Processing Fund of Rs. 2000 crore was set up with **National Bank for Agriculture and Rural Development (NABARD)** to provide affordable credit for investments in setting up **Mega Food Parks (MFP)** as well as processing units in the MFPs.

Discovery of Fossils in Jaisalmer

Why in News?

Workers excavating a **pond in Fatehpur, Jaisalmer district, Rajasthan**, may have uncovered **fossils of a winged reptile** from the **Jurassic period**, potentially 180 million years ago, which could redefine the fossil landscape of western India.

Key Points

- About:** Villagers discovered a **"large bone-like structure"** and stone fossils as hard as wood, with geologists estimating the creature to be **8 to 10 feet long**, and the structure itself measuring 6 to 7 feet.

✦ This discovery would **add a new dimension** to the region's fossil map, complementing previous findings from **Akal and Thaiyat**, which are also believed to be from the dinosaur era.

✦ Teams from the **Archaeological Survey of India (ASI)** and **Geological Survey of India (GSI)** are set to examine the fossils in detail to determine their exact age and species.

First Pravasi Rajasthani Diwas

Why in News?

The **first Pravasi Rajasthani Diwas** will be observed on **10th December 2025 in Jaipur**, alongside the **Rising Rajasthan Partnership Conclave**, to recognize the contributions of Rajasthani migrants to other states and countries.

Key Points

💡 **About:** It is a **two-day conclave** organized as a follow-up to the **2024 Rising Rajasthan Global Investment Summit**, with investor roadshows to be held at key domestic and international locations beforehand.

💡 **Objective:** It aims to **promote partnerships across various sectors** and strengthen the state's relationships with key international and multilateral organizations.

💡 **Events:** The state government will present the **Pravasi Rajasthani Samman Awards** to **Non-Resident Rajasthanis (NRRs)** for their global achievements in business, science, art, industry, philanthropy, social service, and music.

💡 **Significance:** The event will serve as a platform to celebrate the achievements of the Rajasthani diaspora and promote **strategic industrial alliances**.

✦ It will provide Non-Resident Rajasthanis (NRRs) an opportunity to reconnect with their roots and invest in the state's growth and development.

✦ The event aligns with the state government's **NRR Policy 2025**, aimed to ensure sustained engagement with the diaspora and create a supportive environment for investment.

💡 **Other Measures:** The Government of Rajasthan (GoR) had established the **'Rajasthan Foundation (RF)'** in March 2001, under the **Rajasthan Societies Registration Act, 1958** for a sustainable and meaningful connection with the NRRs.

Pravasi Bharatiya Divas (PBD)

💡 **About:** **Pravasi Bharatiya Divas (PBD)** is observed biennially on 9th January, to celebrate the contributions of the **Indian diaspora** to their homeland.

✦ The 18th PBD Convention was organised by Odisha from 8th to 10th January 2025, with the theme 'Diaspora's Contribution to a **Viksit Bharat**' (Developed India).

💡 **Background & History:** This bi-annual celebration commemorates the day in 1915 when **Mahatma Gandhi**, the greatest Pravasi (migrant), returned to India from South Africa to lead the country's **freedom struggle**.

💡 **PBD Conventions:** The PBD Convention was first established in 2003 under the government of then Prime Minister Late **Shri Atal Bihari Vajpayee**, as a platform to recognise and engage with the overseas Indian community.

💡 **Pravasi Bharatiya Samman Award (PBSA):** The award, given out as part of the Pravasi Bharatiya programme, is the highest honour conferred on a **Non-Resident Indian (NRI)**, Person of Indian Origin (PIO); or an organisation or institution established and run by them.

Eradication of Vilayati Babool

Why in News?

The Panchayati Raj Minister of Rajasthan directed officials from the Panchayati Raj and Forest Department to **conduct a study** and issue guidelines for the complete removal of Vilayati Babool (*Prosopis Juliflora*), including its roots.

Vilayati Babool (*Prosopis juliflora*)

- 💡 **About:** Locally known as Vilayati Kikar or Gando Baval, it is an **invasive alien plant species** native to Mexico, South America, and the Caribbean, now prevalent in India's arid and **semi-arid regions**.
- 💡 **Impact:**
 - ✦ The rapid spread of *Prosopis Juliflora* **hampers vegetation growth** and depletes **soil fertility**, reducing agricultural productivity.

- ✦ Its expansion **destroys pasturelands**, creating difficulties for livestock grazing and facilitating the spread of more plants.

Invasive Alien Species

- 💡 **About:** Invasive Alien Species are **non-native organisms** (plants, animals, fungi, or even microbes) introduced beyond their natural range, forming self-sustaining populations.
 - ✦ They outcompete native species, disrupt ecosystems, and cause **significant ecological**, economic, and social impacts.
 - ✦ According to the **Convention on Biological Diversity (CBD)**, IAS are species that can "arrive, survive, and thrive", often outcompeting native species for resources.
 - ✦ In India, the **Wildlife Protection Act, 1972** defines IAS as non-native species that threaten wildlife or habitats.
- 💡 **Other Invasive Alien Species in India:** Animal species like African catfish, Nile tilapia, red-bellied piranha, alligator gar, **Red-eared Slider** (a North American turtle) and plants like Lantana and **Water Hyacinth** are among the most widespread invasive species in India.
