### Answer: (d) Explanation:

- Khilonjias or indigenous people of Assam comprises-following tribal communities:
  - Bodo
  - o Deuri
  - o Dimasa
  - Rabha

- Sonowal Kachari
- Thengal Kachari
- Tiwa

#### Hence, Option (d) is correct.

- 2. With reference to 'Odissi dance', consider the following statements:

# Answer: (a) Explanation:

- Odissi dance has its origin in the temples.
- Odissi closely follows the tenets laid down by the Natya Shastra.
- The carvings found at the **Udayagiri Monastery** denote that Odissi was patronised as early as the  $2^{nd}$  Century BCE.
- The torso movement is very important and is a unique feature of the Odissi style. Hence, Statement 1 is correct.
- Odissi dance depicts largely love themes of Radha and Krishna. **Hence**, **Statement 2 is not correct.**





- 3. Consider the following statements:

- Great Indian Bustard is listed in **Schedule I** of the Indian Wildlife (Protection)Act, 1972. **Hence, Statement 1 is not correct.**
- IUCN Red List- Critically Endangered. Hence, Statement 2 is not correct.
- India is the only country that habitats the Great Indian Bustard. **Hence, Statement 3 is correct.**
- 4. Which of the following appliances has/have an energy rating label mandatorily?
  - 1. Frost-free refrigerator
  - 2. Tubular Fluorescent Lamps
  - 3. Room Air-Conditioners
  - 4. Distribution Transformer

# Answer: (d) Explanation:

- Bureau of Energy Efficiency(BEE) is a statutory body set up under the Energy Conservation Act, 2001.
- BEE gives energy rating labels mandatorily to: **Frost-free refrigerator**, **Tubular Fluorescent Lamps**, **Room Air-Conditioners**, **Distribution Transformer**, Colour TV, CST AC, Direct Cool Refrigerator and Electric Geyser. **Hence, Option (d) is correct.**

# Answer: (b) Explanation:

- The Mandovi River originates at Bhimgat located in the Western Ghats, Karnataka. Hence, Statement 1 is not correct.
- It drains into the Arabian Sea. Hence, Statement 2 is correct.
- It is also known as **Mahadayi** river in Goa.
- Mandovi joins with the Zuari at Cabo Aguada, forming the Mormugao harbour in Goa.
- Panaji, the state capital of Goa is situated on the banks of the Mandovi river.
- It's catchment area lies in Goa, Karnataka and Maharashtra. Hence, Statement 3 is not correct.





- 7. With reference to 'Seke Language', consider the following statements:

- Seke language is mainly spoken in the Upper Mustang district of Nepal. **Hence, Statement 1 is not correct.**
- Seke is classified within the Tamangic branch of the Sino-Tibetan language family, and is thus related to the Tamang, Gurung, Thakali, and Chhantyal languages. **Hence, Statement 2 is correct.**
- The three dialects of Seke are Tangbe, Tetang, and Chuksang.
- 8. With reference to 'Appointments of judges', consider the following statements:
  - 1. The judges of the Supreme Court are appointed by the president and The judges of a High Court are appointed by the Governor.
  - 2. The consultation with the Chief Justice of India is only recommendatory in the case of appointment of a Supreme Court judge other than the Chief Justice.

# Answer: (d) Explanation:

- The judges of the Supreme Court are appointed by the president.
- The judges of a **High Court** are also appointed by the President. **Hence, Statement 1 is incorrect.**
- The consultation with the Chief Justice of India is obligatory in the case of appointment of a Supreme Court judge other than Chief Justice. **Hence, Statement 2 is incorrect.**





- 9. "EVALI" is recently in news related to which of the following?

# Answer: (c) Explanation:

• EVALI is used for e-cigarette, or vaping, product use associated with lung injury.

#### Hence Option (c) is correct.

# Answer: (b) Explanation:

- CSIR (Council of Scientific and Industrial Research) has developed a new low-cost technology to produce Geranium saplings. Geranium plant is originally from South Africa. **Hence, Statement 1 is incorrect.**
- It is predominantly used in manufacturing essential oils. It acts as an antiinflammatory and antiseptic agent. **Hence**, **Statement 2 is correct.**
- 11. Which of the following countries is NOT part of the 'E3' group of countries?
  - (a) Spain
  - (b) France
  - (c) Britain
  - (d) Germany

# Answer: (a) Explanation:

• E3 group of countries — Britain, France, and Germany. These countries are negotiating parties of Iran Deal disputes known as the Joint Comprehensive Plan of Action (JCPOA). **Hence, Option (a) is not correct.**

### Answer: (b) Explanation:

- Previously, the Shillong Declaration and the Jammu Resolution have been adopted for good governance.

Hence, Option (b) is correct.

- It provides a comprehensive insurance cover against failure of the crop thus helping in stabilising the income of the farmers. **Hence, Statement 1** is incorrect.
- The prescribed premium is 2% to be paid by farmers for all Kharif crops and 1.5% for all rabi crops.
- In the case of annual commercial and horticultural crops, the premium is 5%. **Hence, Statement 2 is incorrect.**

- It is located at the Daya River flowing into the Bay of Bengal. **Hence**, **Statement 2 is incorrect.**
- Chilika lake was also designated as a wetland of international importance under the Ramsar Convention in 1981. **Hence, Statement 3 is correct.**
- 17. GAVI sometimes seen in the news is related with:

### **Explanation:**

- The objective is **to promote efficient lighting, enhance awareness** on using efficient equipment that will reduce electricity bills and preserve the environment. **Hence, Statement 1 is correct.**
- It is the world's largest domestic lighting project. Hence, Statement 2 is correct.

- It does not have a **nomination** facility. Hence on the user's death, all the documents uploaded on Digilocker app would not be accessible by his or her kin and would automatically get passed on to the government. Hence, **Statement 3 is incorrect.**
