Answer: (a)

Explanation:

Mulberry accounts for the majority of the total natural silk produced in India.

2. Consider the following statements about Cord Blood
1. Cord blood is the blood from the baby that is left in the umbilical cord and placenta after birth.
 2. It contains special cells called hematopoietic stem cells that can be used to treat some types of diseases.

Which of the statements given above is/are correct?

- (a) 1 only
- (b) 2 only
- (c) Both 1 and 2
- (d) Neither 1 nor 2

Answer: (c)

Explanation:

- Cord blood (short for umbilical cord blood) is the blood from the baby that is left in the umbilical cord and placenta after birth. **Hence statement 1 is correct.**
- It contains special cells called hematopoietic stem cells that can be used to treat some types of diseases.
- **Hematopoietic stem cells** can mature into different types of blood cells in the body. **Hence statement 2 is correct.**

3. Consider the following statements
1. The Red Blood Cells (RBCs) are also known as Leukocytes and contain the iron-rich protein called haemoglobin that gives blood its red colour.
 2. The White Blood Cells (WBCs) are also known as Erythrocytes and are the colourless blood cells as it is devoid of haemoglobin.

Which of the statements given above is/are correct?

- (a) 1 only
- (b) 2 only
- (c) Both 1 and 2
- (d) Neither 1 nor 2

Answer: (d)

Explanation:

- The Red Blood Cells (RBCs) are also known as **Erythrocytes**. RBCs contain the iron-rich protein called **haemoglobin** that gives blood its **red colour**. **Hence, statement 1 is not correct.**
- The White Blood Cells (WBCs) are also known as **Erythrocytes Leukocytes** and are the **colourless** blood cells as it is **devoid of haemoglobin**. **Hence, statement 2 is not correct.**

4. Sahyadri Megha is a new variety of which of the following crops?

- (a) Paddy
- (b) Wheat
- (c) Sugarcane
- (d) Maize

Answer: (a)

Explanation:

The University of Agricultural and Horticultural Sciences(UAHS), Shivamogga, Karnataka has developed 'Sahyadri Megha', a new red variety of paddy. **Hence, Option (a) is correct.**

5. Which of the following is the fastest supercomputer in the world

- (a) Summit
- (b) Sierra
- (c) Sunway TaihuLight
- (d) Tianhe-2

Answer: (a)

Explanation

As of now, the fastest supercomputer on the TOP500 supercomputer list is the Summit, in the United States, with a LINPACK benchmark score of 143.5 PFLOPS, followed by Sierra, by around 48.860 PFLOPS. **Hence, Option (a) is correct.**

6. Consider the following statements regarding Kyasanur Forest Disease:

1. It is caused by protozoa.
2. It was first identified in 1957 in a sick bat from the Kyasanur Forest in Karnataka

Which of the statements given above is/are correct?

Answer: (d)

Explanation:

- **Kyasanur Forest Disease** is caused by **Kyasanur Forest disease Virus (KFDV)**, a member of the virus family **Flaviviridae**. **Hence statement 1 is not correct.**
- It was **first identified in 1957** in a sick monkey from the Kyasanur Forest in Karnataka. **Hence statement 2 is not correct.**

7. Consider the following statements about Ramganga River

1. The River rises from Dudhatoli ranges in the Garhwal district of Uttarakhand.
2. It is a right-bank tributary of the Ganga.
3. Ramganga flows by the Corbett National Park.
4. Kalagarh Dam is an embankment dam on the Ramganga River.

Which of the statements given above is/are correct?

- (a) 1 and 2 only
- (b) 1, 2 and 3 only
- (c) 1, 3 and 4 only

Answer: (c)

Explanation:

- The Ramganga river rises from **Dudhatoli ranges** in the Garhwal district of **Uttarakhand**. **Hence, statement 1 is correct.**
- It is a **left-bank tributary of the Ganga**. It enters the Ganga Plain near Kalagarh. **Hence, statement 2 is not correct.**
- Ramganga flows by the **Corbett National Park** near Ramnagar of Nainital district. **Hence, statement 3 is correct.**
- The **Ramganga Dam**, also known as the **Kalagarh Dam**, is an embankment dam on the Ramganga River. **Hence statement 4 is correct.**

8. Consider the following statements about Nidhi Companies

1. It works on the principle of mutual benefits that are regulated by the Ministry of Finance.
2. Nidhi Companies do not come under the definition of Non-Banking Financial Company (NBFC) and hence they are exempted from regulations of the Reserve Bank of India (RBI).

Which of the statements given above is/are correct?

Answer: (d)

Explanation:

- Nidhi Company is a **company registered under the Companies Act, 2013.**
- It works on the principle of mutual benefits that are regulated by the Ministry of Corporate Affairs. **Hence statement 1 is not correct.**
- Nidhi Company is a class of Non-Banking Financial Company(NBFC) and Reserve Bank of India(RBI) has powers to issue directives for them related to their deposit acceptance activities. **Hence statement 2 is not correct.**

4. Mauritius

Select the correct answer using code given below:

- (a) 1 and 2 only
- (b) 1 and 3 only

Answer: (d)

Explanation:

- Indian Ocean Commission was created in 1982 and was institutionalized in 1984 by the Victoria Agreement.
- Secretariat: Mauritius
- It consists of
 - Madagascar
 - Comoros
 - La Réunion (French overseas territory)
 - Mauritius
 - Seychelles
- The Commission has five observers — India, China, European Union (EU), Malta and International Organisation of La Francophonie (OIF).

Hence, Option (d) is correct.

10. BhoomiRashi Portal works under which of the following ministries

- (a) Ministry of Road Transport & Highways
- (b) Ministry of Rural Development

- (c) Ministry of New and Renewable Energy
- (d) Ministry of Labour and Employment

Answer: (a)

Explanation:

- The BhoomiRashi Portal is an e-Governance initiative of the Ministry of Road Transport & Highways. **Hence, Option (a) is correct.**
- The portal intends to expedite the process of land acquisition for National Highways.

- It has significant implications for climate.
 - It contains vast cryospheric zones and is also the world’s largest store of snow and ice outside the polar region.
- **Generally, areas covered under HKH Region:**
 - Afghanistan
 - Bangladesh
 - Bhutan
 - China
 - India
 - Myanmar
 - Nepal
 - Pakistan
- **Hence, Option (d) is correct.**

13. With reference to the ‘Red Panda’, consider the following statements:

1. It is listed as critically endangered under IUCN Red List.
2. It is the state animal of Sikkim.

Which of the statements given above is/are correct?

- (a) 1 only

Explanation:

- The red panda is a **small reddish-brown arboreal mammal**.
- The only living member of the **genus Ailurus**.
- **Protection Status:**
 - **IUCN Red List: Endangered. Hence, Statement 1 is not correct.**
 - **CITES: Appendix II**
 - **Indian Wildlife Protection Act, 1972: Schedule I**
- **Habitat: India, Nepal, Bhutan Myanmar and southern China**
 - India: Sikkim, Assam, Meghalaya, West Bengal and northern Arunachal Pradesh.
 - It is also the state animal of **Sikkim. Hence, Statement 2 is correct.**

14. Mount Lepethymnus is located in which of the following island

- (a) Island of Lesbos
- (b) Katchatheevu Island
- (c) Island of Anguilla
- (d) Island of Honshu

Answer: (a)

Explanation:

- Lesbos (also called Mitilini) is a greek island.
- The principal peak here is Mount Lepethymnus (3,176 feet). **Hence, Option (a) is correct.**
- It is the largest island after Crete and Euboea in the Aegean Sea.

15. Consider the following statements in respect of Trade Related Analysis of Fauna and Flora in Commerce (TRAFFIC):

1. TRAFFIC is a bureau under United Nations Environment Programme (UNEP).

- It specializes in investigating and analysing wildlife trade trends, patterns, impacts and drivers to provide the leading knowledge base on trade in wild animals and **plants. Hence, Statement 2 is correct.**

1. The GRACE satellites were launched by the ISRO in 2002.

 - The mission was **approved in 2017** at a total cost of Rs 1500 crore and is **50% co-funded by the World Bank loan. Hence, Option (c) is not correct.**
- All other statements are correct.

Explanation:

- The **Laffer curve** is a graphical relationship between taxation and government revenue. **Hence, Option (c) is correct.**
- **Phillips curve** is an economic concept developed by A. W. Phillips stated that **inflation and unemployment have a stable and inverse relationship.**
- **Kuznets curve** graphs the hypothesis that as an economy develops, **market forces first increase and then decrease economic inequality.**
- **Lorenz curve** is a graphical representation of the **distribution of income or of wealth.**

20. Katchatheevu Island, sometimes seen in the news, is an area of concern between India and which of the following countries?

Answer: (b)

Explanation:

- Katchatheevu Island is an uninhabited off-shore island in the Palk Strait.
