- Indian National Space Promotion and Authorisation Centre (IN-SPACe) is a **single-window, independent, nodal agency** that functions as an autonomous agency in the **Department of Space (DOS)**. It is formed following the Space sector reforms to enable and facilitate the participation of private players. **Hence, statement-II is correct.**

Hence, option A is correct because both Statement-I and Statement-II are correct and Statement-II is the correct explanation for Statement I.

 - It **uniquely regulates both a profession and processes**, with oversight over Insolvency Professionals, Agencies, Entities, and Information Utilities.
- The Board is composed of a **Chairperson, three members from the Central Government** who are at least of the rank of a Joint Secretary, representing the Ministries of Finance, Corporate Affairs, and Law ex-officio, one member nominated by the RBI ex-officio, and five other members nominated by the Central Government, of which at least three must be whole-time members. It is **not headed** by the Minister of Corporate Affairs. **Hence, statement 2 is not correct.**
- The Chairperson and members (excluding ex-officio members) serve a **term of five years** or until they reach the age of sixty-five, whichever comes first, and they may be re-appointed. **Hence, statement 3 is correct.**
